Linguistic Diversity Policy	To celebrates the rich diversity of linguistic traditions within the District.	Extending to all forms of linguistic diversity including minority languages generally, sign language, braille and other language forms. IT also recognises the particular needs of those with literacy problems and for whom the written word may not always be fully accessible.	Screened out with no mitigation.
Draft Bonfire Protocol	Assist the Council to comply with its duties under the HSW Order and control risk to members of the public accessing Council property. Same Sex Marriage Motion	The motion states that the Council welcomed the marriage equality referendum in the Republic of Ireland and noted that a number of parliaments across the world had embraced and legislated for marriage equality. The motion goes further to state that the Council believes that marriage equality should be extended to all couples (regardless of sexual orientation) in Northern Ireland.	To state that all couples (regardless of sexual orientation) across the District, and indeed Northern Ireland, should: have the right to a civil marriage; that the rights of religious institutions to define, observe and practice marriage within their beliefs should be given legal protection; that faith groups which wish to marry same sex couples should not be prevented by the state from doing so; that all married couples of the same sex should have the same legal entitlement to the protections, responsibilities, rights, obligations and benefits afforded by the legal institution of marriage. The motion also states that the Council calls on the Executive to introduce legislation to extend civil marriage provisions to same sex couples.'	Screened out with no mitigation.
