Background

Fermanagh and Omagh District Council has secured £2.6m to deliver a PEACE IV Local Action Plan for the district to promote positive relations between people from different backgrounds and communities. The programme is supported by the European Union's PEACE IV Programme, managed by the Special EU Programmes Body (SEUPB).

The PEACE IV Local Action Plan will support 15 programmes or initiatives across three key themes – Children and Young People; Shared Spaces and Services; and Building Positive Relations.

The Local Action Plan was developed following extensive consultation in 2016 with local communities to ensure actions address their needs and issues identified.

A voluntary PEACE IV Partnership - made up of Councillors and representatives from statutory agencies and social partners – will support and monitor the effective delivery of the Local Action Plan.

The PEACE IV Programme is an EU Funded Programme designed to support Peace and Reconciliation in Northern Ireland and the Border Region. It is managed by the Special EU Programmes Body (SEUPB). Matching-funding for this element of the PEACE IV Programme has been provided by the Executive Office in Northern Ireland and the Department of Housing, Planning, Community and Local Government in Ireland.

- Enter into a development agreement to meet the conditions of the PEACE IV Programme as specified by SEUPB and the Council.

Expressions of Interest will be assessed and scored against an agreed 'Cross Border and Cross Community Youth Sport Programme Framework'.

PEACE IV Cross Border and Cross Community Youth Sports Programme

Introduction

In its role as lead partner Fermanagh and Omagh District Council wishes to invite Expressions of Interest under the PEACE IV Cross Border and Cross Community Youth Sports Programme - enhancing the capacity of children and young people to form positive and effective relationships with others of a different background and make a positive contribution to building a cohesive society through minority sports participation.

This element will invest in children and young people so that they can reach their potential and maximise their contribution to a more cohesive society. It will bring about change in the form of clear, meaningful and sustainable 'distance travelled' for individual young people in terms of good relations, personal development and citizenship.

This intervention will **result** in an increase in the percentage of 16 year olds who socialise or play sport with people from a different religious community; who think relations between Protestants and Catholics are better than they were five years ago; and who think relations between Protestants and Catholics will be better in five years' time.

Project Definition

It has been determined that at least 12 Youth Minority Sports Groups should be established or supported in the Fermanagh and Omagh District

The objectives of the Cross Border and Cross Community Youth Sport Programme is to:

- Establish or support a minimum of 12 Youth Minority Sports Groups in sports which are not traditionally played in the Fermanagh and Omagh area and where a recognised club does not currently exist.
- Deliver an inclusive youth initiative, supported by Leisure, Recreation and Sports PEACE IV coaches, involving minority sports that engage young people in sporting activities which they enjoy while forming positive relationships with people that they would not normally socialise or play sport with.
- Provide training for members to attain coaching / leadership qualifications in order to sustain sport clubs post funding, build on their capacity and create networks for implementation and delivery of sporting leagues.
- Develop cross community and cross border links through partnership delivery, coaching, participation and competition.



The delivery team will endeavour to achieve as equitable spread across the District Council area as possible.

For the purposes of this programme please see the following definitions:

- **Youth / Young People:** 8 - 24 age range.
- **Minority Sports:** sports which are not traditionally played in the Fermanagh and Omagh area.

A minimum of 240 young people from both communities will be participating in a new sport in line with the requirements of the PEACE IV Programme. The level of engagement for each young person will equate to a minimum period of 6 months and/or 26 hours of participation in coach-led sessions.

To under-pin the delivery of the programme and support sustainability beyond the period of the programme, a minimum of 24 young people / members will be trained in specific minority sports coaching.
