Presentations were received from Partners NIHE and DAERA.

1. **Grainne Mullin, Head of Housing for All, NI Housing Executive, on the NIHE Irish Traveller Accommodation Strategy and Call for Sites.** The Strategy aims to address the range of accommodation needs of Irish Travellers and ensure the provision of adequate and suitable accommodation for Irish Travellers that meets their needs, promotes their equality of opportunity and promotes good relations among Traveller households and between Travellers and other members of the community.

2. **Dr Jason Foy, Director of Rural Affairs, DAERA, on Rural Policy**, which aims to support, understand and champion sustainable and inclusive rural places and people.

What was the focus of the meeting?

- Internal Audit of Community Planning by FODC and some key findings outlined.
- Alignment and commonality of FO 2030 and the recently launched Programme for Government.
- Risk Register updated focusing on updating Governance Framework, demonstrating collective impact and updating the Communications and Engagement Strategy and protocol.
- People and Communities Co-Lead appointed (PHA, Fiona Teague) and a focus on whole system approach to tackle obesity.
- Labour Market Partnership (LMP) and Local Economic Partnership (LEP) progress outlined including the next steps in developing the Sub Regional Economic Plan and the priorities of the LMP Action Plan.
- Community Voluntary Sector (CVS) Forum provided a comprehensive overview of activities within the sector relevant to respective outcomes, including Age Friendly and Poverty.
- Areas Integrated Partnership Boards (AIPB) and what progress has been made with a focus on process to identify priorities and data sharing.

Recommendation approved included:

- Close alignment and commonality between the [Fermanagh and Omagh 2030 Community Plan](#) and the [Programme for Government \(PfG\) 'Our Plan: Doing What Matters Most'](#)
- Community Planning Risk Register updated to add in three new risks.
- The Public Health Agency approved as co-lead for the People and Communities Theme along with a whole system approach to obesity prevention as a key focus of the group.
- Writing to the Education Minister requesting departmental support for a nutritional literacy programme piloted within selected primary schools in Omagh

Attendance Rate of members at June meeting: 73% of members attended the in person meeting.
