## Re-Notification

Fermanagh and Omagh Local Development Plan 2030: Draft Plan Strategy – Public Consultation on site specific policy representations (counter representations)

The Council recently identified an inadvertent error in the notification procedures for the original consultation on counter representations to its Draft Plan Strategy. As you made a representation to the draft Plan Strategy, I write to you to advise that the Council is undertaking a rerun of the consultation period for the receipt of counter representations in accordance with Regulation 17 of the Planning (Local Development Plan) Regulations (Northern Ireland) 2015 (the 'LDP Regulations'). This is ensure that the Draft Plan Strategy is fully compliant with the legislation. The new 8-week period will commence on Thursday 2<sup>nd</sup> May 2019 and end on Thursday 27<sup>th</sup> June 2019.

If you previously sent us a counter-representation in response to the 14th February-11<sup>th</sup> April 2019 consultation period, this has been returned to you. It must be re-submitted by 27<sup>th</sup> June 2019 if you wish it to be considered at Independent Examination. We apologise for the inconvenience this may cause.

The purpose of a counter representation is to provide an opportunity to respond to site specific policy representations submitted to the draft Plan Strategy under Reg 15 and 16 of the LDP Regulations. "Site specific policy" means a policy in a development plan document which identifies a site for a particular use or development. "Site specific policy" representation means any representation which seeks to change a development plan by —

- a) adding a site specific policy to the development plan document: or
- b) altering or deleting any site specific policy in the development plan document.

Any person may make a counter representation in relation to a site specific policy representation and should indicate the reasons for doing so in terms of soundness and sustainability of the draft Plan Strategy. However, a counter representation must not propose any further changes to the draft Plan Strategy. You must clearly state the Reference of the submission to which your counter representation relates.
