## Return of your Counter Representation and Re-Notification of the

Fermanagh and Omagh Local Development Plan 2030: Draft Plan Strategy – Public Consultation on site specific policy representations (counter representations)

The Council recently identified an inadvertent error in the notification procedures for the original consultation on counter representations to its Draft Plan Strategy. I write to you to advise that the Council is undertaking a rerun of the consultation period for the receipt of counter representations in accordance with Regulation 17 of the Planning (Local Development Plan) Regulations (Northern Ireland) 2015 (the 'LDP Regulations'). This is to ensure that the Draft Plan Strategy is fully compliant with the legislation. The new 8-week period will commence on Thursday 2<sup>nd</sup> May 2019 and end on Thursday 27<sup>th</sup> June 2019.

As you previously sent us a counter-representation in response to the 14th February-11<sup>th</sup> April 2019 consultation period, this is now being returned to you and is attached. It must be re-submitted by 27<sup>th</sup> June 2019 if you wish it to be considered at Independent Examination. We apologise for the inconvenience this may cause.

The purpose of a counter representation is to provide an opportunity to respond to site specific policy representations submitted to the draft Plan Strategy under Reg 15 and 16 of the LDP Regulations. "Site specific policy" means a policy in a development plan document which identifies a site for a particular use or development. "Site specific policy" representation means any representation which seeks to change a development plan by —

- a. adding a site specific policy to the development plan document: or
- b. altering or deleting any site specific policy in the development plan document.

Any person may make a counter representation in relation to a site specific policy representation and should indicate the reasons for doing so in terms of soundness and sustainability of the draft Plan Strategy. However, a counter representation must not propose any further changes to the draft Plan Strategy. You must clearly state the Reference of the submission to which your counter representation relates.





Fermanagh and Omagh District Council – draft plan strategy 2030 **Responses to Consultation.** 

I write in my capacity as Chairman of *Omagh Cycling Initiative*, a local group dedicated to promoting cycling in the Omagh area as an enjoyable means of transport which contributes to health and fitness and is a clean and cheap method of travel. We have had, and have, a close working relationship with Fermanagh and Omagh District Council on many measures aimed at improving facilities for cycling, and thereby alleviating congestion, while enhancing the fitness of all ages of road users.

It is therefore disappointing to see how little response has been received to date which encourages cycling; in fact, only DPS 317, from The Department for Infrastructure, comments: "It is our view that this policy is only focused on the car and traffic. Accessibility appears in the title however it is not considered or referred to within the policy wording. --- no reference is made to active travel and sustainable transport."

The Department goes on to state: "DFI are committed to achieving an increased proportion of journeys made by walking, cycling and public transport. In order to achieve this, walking and cycling as everyday means of transport, within urban areas, must be made easier." It goes on to demand that policy wording should support new developments providing safe and convenient pedestrian and cycle use, --- and safe and secure cycle parking facilities, and that major developers be required to do likewise.

*Omagh Cycling Initiative* strongly supports the views of DFI. It is most disappointing that the only site-specific references to cycling routes are in Infrastructure, section 6.37, and are both in Fermanagh. Also, in Table 8-1, no targets are stated for ANY footpaths or cycle paths.

I would appreciate if the above comments, which represent the considered opinion of Omagh Cycling Group members, are afforded due weight when the final Strategy Plan is prepared.
