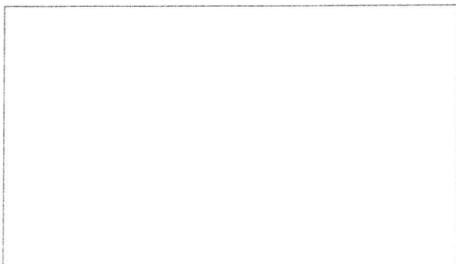

1. Relevant Background and Introduction

1.1 The purpose of this report is to:

1.1.1) inform Members of the instances when Enniskillen Castle and Strule Arts Centre were illuminated for charitable causes from December 2019 until March 2020, in accordance with the Councils External Lighting Policy 2015; and

1.1.2) to provide Members with an update on the Green Road Public Right of Way (PRoW), Greencastle.

1.2.1 Illuminations

Members will recall that approval was granted at the Council Meeting on 5 November 2019 that future requests for illumination of Council buildings could be delegated to Officers and reported retrospectively to Committee, provided that they were not contentious requests.

1.2.2

Green Road Public Right of Way

At the Council Meeting on 4 December 2018 it was resolved that the Council asserts the Green Road as a PRoW and requested officers to have it vindicated in the County Court. This report provides an update on that process and the next steps to be undertaken.

2. Key Issues

2.1.1 Illuminations

The Council received nine requests to light up Council buildings between December 2019 and end of March 2020. Eight took place, with the request to light up for the Purple Flag Assessment visit not taking place due to the Assessment visit being cancelled because of the COVID – 19 situation. The table below provides a summary of the requests.

2.1.2 Green Road Public Right of Way

Discussions have been ongoing with our barrister and junior counsel who have been dealing with the issue on behalf of the Council. There has been a delay in progressing the work from the junior counsel but proceedings, and a letter of claim, have been drafted. The Letter of Claim must be sent out to each landowner along the route to obtain their approval, via signature, that they are content with the route being asserted as a PRow. For those landowners who do not provide approval, the Council will have to issue court proceedings to the County Court. This fact will be included in the Letter of Claim. This process was about to commence when the COVID crisis started and it was decided to postpone the issuance of the letters.

Next steps in the process of assertion include:

- Review the list of landowners to establish that no details have changed since the Council were last in contact
- Personally contact each landowner to inform them that the Letter of Claim for assertion of the Green Road as a PRow is on its way. In this way landowners will not be shocked by inclusion in the letter of the prospect of being taken to Court. This process could be completed in the next 4-6 weeks.
- Issue Letter of Claim to landowners and allow a period of up to 4 weeks for return.
- For those who do not agree with the proposed assertion of the Green Road as a PRow issue court proceedings to the County Court.
- Await the cases to be heard in the County Court - this could take a period of 6-12 months from the date of lodgement.

At the end of this process the PRow may or may not be established.

We are instructed by Fermanagh and Omagh District Council. In accordance with provisions set out in the Access to the Countryside (NI) Order 1983 the Council, pursuant to Article 3 of that Order asserts that the route located between Greencastle and Rouskey, County Tyrone which is shown on the map attached hereto is a public right-of-way. You are the owners of land on which the public right-of-way is located. The Council intends to issue proceedings seeking a declaration that the route located shown on the map is a public right-of-way on foot and an order that you or any other owner of land along the route shall be prohibited and restrained from obstructing and interfering with the public enjoyment of the right-of-way.

Before issuing proceedings Council would like to give you this opportunity to confirm in open correspondence that you agree to the existence of the public right-of-way. I would be grateful to hear from you in this regard within 3 weeks from the date hereof. If we do not hear from you then proceedings will be issued without further or other notice and use may be made of this correspondence in respect of costs.

I am coming back to you belatedly on this, as I had wanted to check a couple of matters with Philip before responding substantively.

There is a report going to R&C next week, which you might have seen, but in summary the status of the assertion is:

A Letter of Claim has been drafted and this must be sent to each landowner along the route. This process was about to commence when the COVID 19 crisis emerged. The Letter of Claim must be signed by each landowner to say that they are content with the route being asserted as a PROW. If there are any landowners who do not agree, the Council will have to issue court proceedings to the County Court. This fact will be included in the Letter of Claim

An indicative timeline is included in the report, and before issuing the letters of claim, we are currently confirming there have been no changes to the landowners.

In terms of your request to access the information, Philip's advice is that as this is matter which may result in legal proceedings, it would not be appropriate for the documentation to be available for such access. This is the matter which has delayed me responding to you, as I wanted to confirm Philip's opinion, and if you wish, I can have him summarise this for you.

Dear Madam,

I note with serious concern from the FODC website, that the *Regeneration and Community Committee* intends to discuss the Council's proposed legal action to adopt the so-called Green Road, near Greencastle, at the meeting on Tuesday 9th June 2020.

Given that I and others have had barely 24hrs notice of this happening, I would like through this email, to urgently place on record my serious concerns about this course of action by FODC.

Frankly, I believe this is one of the most ridiculous legal actions I have ever seen being promoted by a Council and for it be advocated in the midst of a Covid-19 pandemic when Council finances are already in crisis, is shameful.

The so-called Green Road may have been an ancient path in our area, and there are many other variations along that route, but it has not been used as such since the 1800s. Nobody actively uses it because nobody can use it.

In total, the alleged Green Road crosses 23 separate landholdings i.e. 23 separate pieces of land owned by 23 separate landowners. All of these lands are separated by wire fences and clear boundaries so nobody ever walks on the long abandoned Green Road. To suggest otherwise is a nonsense. The Council's own report even said there was no evidence of use!

In terms of the 23 landowners that FODC previously contacted about this matter:

- 8 said it is not a right of way.
- 7 said it is a right of way.
- 8 did not respond.

So, only 7 of the 23 landowners actually agreed that this is a public right of way.

The purpose of this email (written Without Prejudice to our own legal position) is to ask you to immediately defer any further action by the Council on this matter, until you and your Councillors are in possession of ALL the facts around this case.

It is my view that the vast majority of FODC Councillors do not know anything about this issue and worse still, did not realise the precedent they will set if they are successful.

To be clear, even if FODC was successful with this case, it will set a precedent and open the floodgates for a multitude of objector and interest groups, to demand that FODC undertakes similar legal action to assert ancient rights of way over privately owned land throughout the FODC area.

So, for FODC to promote this legal action using ratepayer's money, it is not only unprecedented and highly unusual, it is financially reckless.

These ancient (and abandoned) rights of way exist everywhere in Fermanagh and Tyrone, across the Healy Park site in Omagh, across the Strule Education Campus site, across the Omagh Hospital lands, across farms in Lisnarick and Lisnaskea. It is very easy to find them. They are all around us but they are not publicly used any more.

Some of the questions which I believe need to be put to you, as the Chief Executive of FODC, along with fellow Council Officers, are:

- i. Has the Council considered asking the opinion of the farming communities across Fermanagh and Tyrone, about setting a precedent to use ratepayer money to fund legal actions to publicly adopt ancient rights of way over private land?
- ii. What public consultation has taken place to justify this highly selective and unusual use of ratepayer money?
- iii. Is it normal for a Council to pursue open-ended litigation of this nature, when only 7 of 23 land-owners affected actually agree?
- iv. Has the new Council intake of elected representatives been fully briefed on this issue or is this just a policy that is being followed from the previous Council?
- v. What are the projected legal costs for taking the case through to the High Court and potentially all the way to the Supreme Court in London? (NOTE: These costs will run into hundreds of thousands if not millions of pounds. In addition those Councillors who vote for this will be responsible and potentially personally liable.)

I also note that in the report to the Council meeting on Tuesday 9th June, your Officers are asking Councillors to endorse taking legal action against me and the other landowners who do not wish to have this public right of way adopted across our land. How would you feel if the Council was doing this to you?! I think it is outrageous.

As I have said above, I would urge you and your Council colleagues to suspend and defer any further action and expense by FODC on this matter.

Councillors should demand a full report from your Council officers on the reasons for this action and the projected legal costs.

In my opinion, Councillors should review and debate this matter internally but there is one, and only one, sensible outcome – to terminate and drop this legal action as soon as possible.

I write further to my email of last Monday to thank the Council meeting of 9th June, for supporting the deferral of any further action by the Council regarding the Green Road issue, until a full and detailed report on it has been received.

As I explained previously, the so-called 'Green Road' no longer even exists. Only 7 of the 23 landowners involved who were contacted by the Council agree that it is a right of way. The Council's own report on the issue could find **no evidence of use** of the so-called right of way over our land – hardly surprising given it is blocked by fences and ditches and hasn't been used since the 1800s.

I read last week that a farmer in England has been successfully sued by a walker for over £1million after she was injured by livestock walking across his land.
Do I sue the Council or the Councillors who voted for it, if this happens to me?

Is it open season for ramblers in the Fermanagh Omagh Council area to use ratepayer money to fund multiple legal actions to forcibly adopt ancient abandoned rights of way, over farms in Fermanagh and Tyrone?

Has anyone asked the farming community of our Council area what they think about this?

For the Council to get itself ensnared in this type of litigation, at the behest of a small group of objectors to a planning application, is completely ridiculous and sets a very dangerous precedent.

I intend to write to the Council Chief Executive in the next fortnight to reinforce my arguments as to why the Council should drop the issue and terminate its use of ratepayer's money on it. I understand , may also write on behalf of the other landowners as well. This is a ludicrous waste of time and money for us all and it needs to stop.

In the meantime, I have been made aware that the '*Silent Majority*' group will be speaking to Councillors tonight setting out the views of a substantial number of people in our community who support the Dalradian mine project. As you probably know, there has been a campaign of bullying and intimidation by a small number of people in our area who want to prevent mining and who also want to silence others from supporting it.

I would ask you to please help ensure that the group is treated respectfully and allowed to explain why it is believed that the mine, and all the investment and jobs that will come with it, will be of great benefit to our area.

People have been bullied into silence until now, they will not be silenced anymore.



Summary Points

- The Council has a duty to:
 - Assert, protect and keep open and free from obstruction any public right of way
 - Compile and preserve maps of the rights of way in its area
 - Signpost paths, where necessary, to help anyone who does not know the area
 - Contribute at least a quarter of the cost of maintaining stiles and gates
- Aside from that, should the Council so decide to, it also has the powers to:
 - Maintain any public right of way
 - Authorise the erection of new stiles and gates
- The onus does not fall on the Council to maintain the PRoW but if the Council does decide to maintain the PRoW through its leisure provision, the Council will then become responsible for the Public Liability of the route. If not, the landowner will be responsible for liability.
- The standard to which a PRoW needs to be maintained is minimal, particularly in rural areas – only enough so that those who are reasonably fit in light active gear can easily pass. However, if the Council does agree to take on responsibility of maintenance there are wider obligations about visitor safety and so this standard may not be acceptable.
- Regardless if the Council agrees to maintain or not, the Council has a duty to ensure the landowner doesn't intentionally block the PRoW. If he/she does, the Council must remove the obstruction. It should agree works with the landowner but if agreement can't be met, then legal advice may need to be sought. (If this is a building Council may not have the power to remove and again, legal advice will need to be sought)

Council's duties for asserted Public Rights of Way

According to the Guide to Public Rights of Way and Access to the Countryside guidance produced by the Government, the Key Provisions of the Access to the Countryside (NI) Order, 1983 for Councils is as follows:

The Council has a duty to:

- Assert, protect and keep open and free from obstruction any public right of way
- Compile and preserve maps of the rights of way in its area
- Signpost paths, where necessary, to help anyone who does not know the area
- Contribute at least a quarter of the cost of maintaining stiles and gates

Aside from that, should the Council so decide to, it also has the powers to:

- Maintain any public right of way
- Authorise the erection of new stiles and gates

The Landowner's and occupiers' duties and rights are as follows:

A duty to:

- Maintain stiles and gates so they are convenient and safe to use

A right to:

- Put up, with the Council's permission, additional stiles and gates where they are needed to restrict animals
- Claim back a quarter of the repairs to existing stiles and gates

Liability Issues

The long-standing principle has been – and remains – that an occupier has no responsibility towards users for the condition or safety of the path. A user would need to prove that the owner was guilty of misfeasance (i.e.. doing something that then caused injury or damage, such as a negligent repair) as distinct from simply nonfeasance (i.e.. failing to do anything to maintain the way).

Where the council exercises its powers to maintain a public right of way it similarly may become liable for misfeasance (although this would normally be covered by its public liability insurance).

Following two different Public Liability cases in NI the Law Reform Advisory Committee for Northern Ireland set out in a discussion paper published in April 1993, were that there is a distinction between urban and rural rights of way and that "It should be obvious to users of rural rights of way that the

paths have not been made up and that they therefore cannot reasonably expect that degree of maintenance that would be appropriate for a properly constructed urban road or footpath dedicated to public use”.

Apart from the landowner's specific duty under Article 5 of the Access Order to ensure that any existing gates and stiles are safe to use (and to comply with any conditions attached to a consent under Article 6 to put up additional ones) a claim against the occupier would succeed only if the plaintiff could prove misfeasance. In simple terms, this means that the occupier must not deliberately set out to injure a path user, nor do anything that is blatantly negligent (such as leaving an open excavation on the line of a path) or which obviously presents a hazard (such as putting up an obstruction which could lead to injury).

If Council did agree to maintain gates and stiles etc, it would be essential that the Council ensure that all gates and stiles were up to standard and safely inspected etc. so that should a claim arise, the Council is not negligent. The landowner would also need to be made aware that should the Council agree to maintain the gates and stiles, the onus is on the landowner to ensure there is no misfeasance for the other sections of the PRow or they may be held accountable should a claim arise.

It is worth noting that when the legislation refers to “maintain”, the word maintain has been judicially interpreted as meaning “to put a highway in such repair as to be reasonably passable to the ordinary traffic of the neighbourhood” and “to restore to a sound or unimpaired condition” any highway or bridge “which has become unsound or impaired through neglect or use”. Under this power the council would, for example, be able to repair the surface of a path and remove scrub and overgrowth from the surface. The power does not extend to dealing with man-made obstructions, however, such as by removing a barbed wire fence. Nor does it allow the council to make improvements to the path, other than those which are incidental to any maintenance, without prior consent from the landowner.

Where the owner or occupier fails to comply with his or her duty under Article 5 (to maintain existing stiles and gates, etc) or Article 7 (not to plough a headland path and to restore ploughed cross-field paths) the council may, after giving 14 days' notice, “take all necessary steps” to rectify the deficiency and recover its costs. Such action must be limited to that which is reasonable to remedy the owner's deficiency.

The requirement to protect and maintain Public Rights of Way

It is less clear where the duty to maintain any public rights of way might lie. What is certain is that the duty does not rest with the owner or occupier of the land. This long-standing principle has repeatedly been reaffirmed by the courts, including in a number of recent cases. The owner may, of course, keep the path in good repair for his or her own use or may choose to repair the surface so it is easier for others to use. But he or she has no obligation, as such, to keep a path in a suitable condition for the public to use.

It is unclear where the responsibility for repairing public rights of way in Northern Ireland might lie. If the path is one that has existed for many centuries, then it is conceivably possible - although unlikely - that responsibility might be found to lie with the district council. But it is much more likely

that the courts would find that a right of way is repairable by no-one, and the public must accept the path in whatever condition they find it.

The council does, however, now have discretionary powers under Article 3 of the Access Order to maintain any public right of way if it chooses to do so. With the growing importance of public rights of way for recreation, and the benefits rights of way can bring, the Department would urge every council to be willing to use this power to ensure the paths in its area are in good condition and are easy and enjoyable to use.

Dealing with obstructions and encroachment

District councils have a duty to protect and keep open and free from obstruction any public right of way - Article 3 (1). Councils may also, after consultation with the owner of the land concerned, maintain any public right of way.

The term keep open and free from obstruction is not defined but traditionally this was taken as the duty to undertake such work as necessary to enable passage along the route by a reasonably active person, wearing appropriate walking clothes.

Vegetation such as fallen trees, dense brambles or nettles may be considered as obstructions; as would any barrier erected across the route which does not permit easy passage.

Minor flooding, long grass or uneven surfaces may not be considered as obstructions.

Councils may also, after consultation with the owner of the land concerned, maintain any public right of way. This can be taken to involve minor works other than that required to keep a path open and free from obstruction.

In Northern Ireland, there is no clear duty placed on anyone to maintain public rights of way but, if district councils assume responsibility as part of their leisure function, a general approach might be based upon the following:

The extent of maintenance is that required to keep the route reasonably passable, at all seasons of the year, for the ordinary traffic of the neighbourhood, of all classes entitled to use the way (e.g. walkers, horses, etc)

Path maintenance should be in keeping with the likely level of usage. For example, a route leading to a church or graveyard might be expected to be maintained to a higher level than a seldom-used remote path in the countryside.

The council should endeavour to act quickly to deal with any obstruction or encroachment of a right of way that is reported to it, or which it finds from its own inspections.

Sometimes, public rights of way can be damaged by the legitimate use of farm tractors (often by the landowner only); other than by persuasion, Councils have no power to prevent this. In extreme cases, EHS can consider grant aid for upgrading such routes to provide a surfaced road suitable for all users.

If the path is one that is being restored to good condition after a period of neglect, the removal of any obstructions will normally be part of a comprehensive programme of work drawn up and agreed with the owners and occupiers concerned. In these circumstances it will clearly be sensible to deal with all natural vegetation at the same time, whether growing from the surface of the path or overhanging from the sides. The division of responsibility suggested above should therefore be applied liberally and the council should be willing (with the owners agreement) to undertake all of the clearance that is required. Alternatively, the owner might agree to do so, with a small financial contribution from the council to cover clearance of the path surface.

It should be noted that council's powers to restore a ploughed path (see section 5.4.2) do not extend to dealing with any crops that are growing on the line of a right of way. They must therefore be dealt with as an obstruction.



Proposed wording of Call-in, please see below:

We, the undersigned Fermanagh & Omagh District Councillors, submit a requisition to 'call-in' Agenda Item 7.9 (1.2.2 in relation to the Green Road Public Right of Way) from the Regeneration and Community Committee Meeting which took place on Tuesday 9th June, as we believe that the decision was not arrived at after a proper consideration of the relevant facts and issues (under Section 41 (1)(a)) and which was unduly influenced by an external e-mail which was not received by all elected Councillors.

Some of the reasons we are requesting the decision be called-in include, but are not exclusive to:

The decision taken by Fermanagh and Omagh District Council was to assert the Green Road as a Public Right of Way, and this decision was made in 2017, following contact from local residents in 2016 – what has delayed the process for three years that we are seemingly no further forward now – what were the issues with Junior Counsel mentioned in the agenda (2.1.2, p2 of the report); why was the decision taken to suspend sending out the Letters of Claim at the start of the COVID crisis; who made this decision; why was Council not consulted;

What are the legal requirements expected of the Council since declaring that FODC will assert the Green Road as a Public Right of Way? What is the legal process, and how can this be progressed at a pace that would be more acceptable to local residents in Greencastle – taking 4-6 weeks to contact one or two dozen land owners to inform them that this letter is on its way seems an extortionate wait considering the length of time it has taken to get us to this point;

Is the Council eligible for potential legal costs, or does this charge fall to the landowner(s) objecting to the assertion of the Public Right of Way;

Why was the Council's Solicitor not present when this item was discussed, and can he be present should the call-in be accepted, as perhaps he could answer some of the questions listed and in need of an answer rather than delaying this process any further unnecessarily;

There is a note on p.3 of the report that 'at the end of this process the PRow may or may not be established' – is this the case, or has FODC already, in fact, begun the process of asserting the Public Right of Way, which could only be stopped if a legal argument is upheld against it, and how likely is that to happen given the information, correspondence, etc. that the Council has received on this subject;

Finally we note that there are no negative Equality & Good Relations or Rural Proofing Implications if we proceed to the next step of asserting the PRow, and it is noted that this "initiative supports the social pillar of sustainable development" (p.4).

I write further to my email of last Monday to thank the Council meeting of 9th June, for supporting the deferral of any further action by the Council regarding the Green Road issue, until a full and detailed report on it has been received.

As I explained previously, the so-called 'Green Road' no longer even exists. Only 7 of the 23 landowners involved who were contacted by the Council agree that it is a right of way. The Council's own report on the issue could find **no evidence of use** of the so-called right of way over our land – hardly surprising given it is blocked by fences and ditches and hasn't been used since the 1800s.

I read last week that a farmer in England has been successfully sued by a walker for over £1million after she was injured by livestock walking across his land.

Do I sue the Council or the Councillors who voted for it, if this happens to me?

Is it open season for ramblers in the Fermanagh Omagh Council area to use ratepayer money to fund multiple legal actions to forcibly adopt ancient abandoned rights of way, over farms in Fermanagh and Tyrone?

Has anyone asked the farming community of our Council area what they think about this?

For the Council to get itself ensnared in this type of litigation, at the behest of a small group of objectors to a planning application, is in my view completely ridiculous and sets a very dangerous precedent.

I intend to write to you in the next fortnight to reinforce my arguments as to why the Council should drop the issue and terminate its use of ratepayer's money on it. I understand Doris McMahon Solicitors may also write on behalf of the other landowners as well. This is a ludicrous waste of time and money for us all and it needs to stop.

In the meantime, I have been made aware that the '*Silent Majority*' group will be speaking to Councillors tonight setting out the views of a substantial number of people in our community who support the Dalradian mine project. As you probably know, there has been a campaign of bullying and intimidation by a small number of people in our area who want to prevent mining and who also want to silence others from supporting it.

I would ask you to please help ensure that the group is treated respectfully and allowed to explain why it is believed that the mine, and all the investment and jobs that will come with it, will be of great benefit to our area.

People have been bullied into silence until now, they will not be silenced anymore.

1. Relevant Background and Introduction

- 1.1 The purpose of the report is to provide Members with an update on the estimated costs associated with any potential County Court proceedings in asserting the Green Road as a Public Right of Way (PRoW), and to note the future process of assertion.

- 1.2 A recommendation to proceed with the assertion process was deferred at the June Regeneration and Community Committee meeting pending consideration of a report on the costs associated with any potential County Court proceedings and the future protection of the Green Road PRoW.

2. Key Issues

- 2.1 Potential costs associated with assertion of the Green Road as a PRoW

2.1.1 In order to assert the Green Road as a PRoW all landowners directly affected must agree to the assertion. If there are landowners who are not content with the decision the Council will be required to issue court proceedings to the County Court against each defendant, on an individual basis. Following a County Court ruling should either party wish to appeal the decision this appeal would be heard in the High Court.

2.1.2 Costs associated with the court case will be on the equity scale. County Court costs should be capped at approximately £4,000 per party to the proceedings (per defendant) for the first day, and £1,200 per defendant for every day thereafter. Further legal costs are estimated at £5,000 for proceedings lasting for one day, and £3,000 for each subsequent day.

2.1.3 If five landowners did not consent to the route being asserted as a PROW the costs in the County Court, for a process lasting 2 days, would therefore be £34,000 (£20,000 court costs for the first day, £6,000 court costs for the second day, £5,000 legal costs for the first day and £3,000 legal costs for the second day).

2.1.4 If an appeal were to take place to the High Court, following the County Court proceedings, costs would be in the same magnitude as those experienced in the County Court.

2.2 Responsibilities of Council in relation to PROW

2.2.1 The Council has a duty to:

- Assert, protect and keep open and free from obstruction any PROW
- Compile and preserve maps of the rights of way in its area
- Signpost paths, where necessary, to help anyone who does not know the area
- Contribute at least a quarter of the cost of maintaining stiles and gates

Aside from that, should the Council so decide to, it also has the powers to:

- Maintain any PROW
- Authorise the erection of new stiles and gates

2.2.2 The onus does not fall on the Council to maintain the PROW but if the Council does decide to maintain the PROW, the Council will then become responsible for the Public Liability of the route. If not, the landowner will be responsible for liability.

2.2.3 The standard to which a PROW needs to be maintained is minimal, particularly in rural areas – only enough so that those who are reasonably fit in light active gear can easily pass. However, if the Council does agree to take on responsibility of maintenance there are wider obligations about visitor safety and so this standard may not be acceptable.

2.2.4 Regardless if the Council agrees to maintain or not, the Council has a duty to ensure the landowner doesn't intentionally block the PROW. If he/she does, the Council must remove the obstruction. It should agree works with the landowner but if agreement can't be met, then legal advice may need to be sought.

2.3 The next steps in the asserting the Green Road as a PRow were outlined in the Regeneration and Community Committee report in June 2020. These included:

- Review the list of landowners to establish that no details have changed since the Council were last in contact;
- Personally contact each landowner to inform them that the Letter of Claim for assertion of the Green Road as a PRow is on its way. In this way landowners will not be surprised by inclusion in the letter of the prospect of being taken to Court. This process could be completed in a number of weeks;
- Issue Letter of Claim to landowners and allow a period of up to 4 weeks for return.
- For those who do not agree with the proposed assertion of the Green Road as a PRow issue court proceedings to the County Court;
- Await the cases to be heard in the County Court - this could take a period of 6-12 months from the date of lodgement.

3. Resource Implications

3.1 Financial

Potential estimated financial costs of litigation are as follows

	Court Costs	Legal Costs
First day of proceedings	£4,000 per defendant	£5,000
Second and subsequent days of proceedings	£1,200 per defendant	£3,000

If the Council agrees to maintain the Green Road PRow the annual cost is estimated between £1,500 and £2,000 per annum.

Officer time will be required in asserting the route as a PRow, included in normal budgets

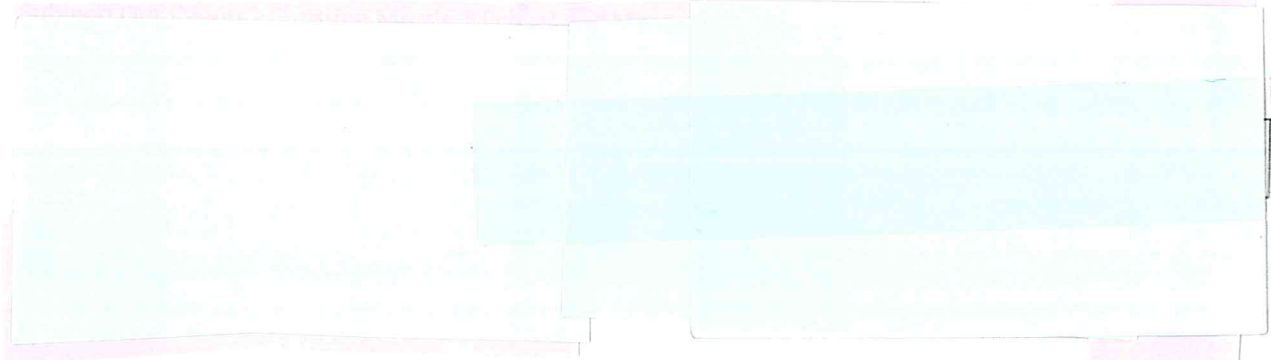

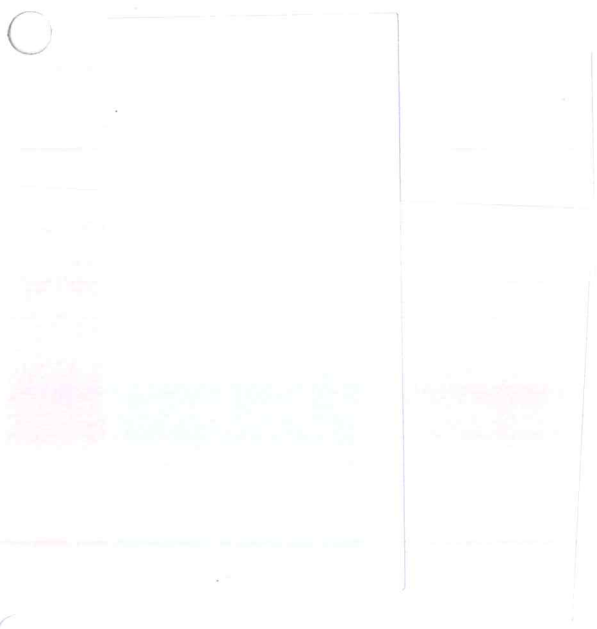

Our Clients –

We refer to the debate which took place at the Regeneration and Community Committee on 9 June 2020 in respect of the alleged public right of way over land described as the "Green Road", near Greencastle.

As previously advised, we act for the above-named clients, all of whom object to Fermanagh and Omagh District Council's (FODC) proposed assertion of this so-called right of way and whose intention it is to resist any such assertion, which has been clearly documented. The reference at paragraph 3.1.2 of the written report to the Regeneration and Community Committee on 9 June to "potential costs" of issuance of proceedings in the County Court is, in our view, misleading as Council officers had clear notice that, should the Council proceed with the proposed assertion, costs of proceedings are inevitable and not merely potential.

Indeed, the strength of opposition on the part of our clients and also on the part of other land owners is such that the costs of proceedings could be many hundreds of thousands of pounds. In this current climate of financial uncertainty and pressure on public finances, we welcome the decision by the Committee to have the matter reconsidered to determine whether the Council should get involved in this at all.

We now wish to set out a number of factors which we believe should be taken into consideration:

1. Potential liabilities from costs arising

For the sake of clarity and full transparency around potential liabilities arising, any report to your Committee on this 'Green Road' subject should advise the Council around:

Our clients wish to make it clear that they have no wish to become embroiled in a legal dispute with FODC. However, they are equally clear in their determination to protect their rights with regards to their own private lands. We would therefore appeal to you and your Council colleagues to reflect on this now and discontinue the Council's involvement in the 'Green Road' issue.

1. Relevant Background and Introduction

- 1.1 The purpose of the report is to provide Members with an update on the estimated costs associated with any potential County Court proceedings in asserting the Green Road as a Public Right of Way (PRoW), and to note the future process of assertion.

- 1.2 A recommendation to proceed with the assertion process was deferred at the June Regeneration and Community Committee meeting pending consideration of a report on the costs associated with any potential County Court proceedings and the future protection of the Green Road PRoW.

2. Key Issues

- 2.1 Potential costs associated with assertion of the Green Road as a PRoW

2.1.1 In order to assert the Green Road as a PRoW all landowners directly affected must agree to the assertion. If there are landowners who are not content with the decision the Council will be required to issue court proceedings to the County Court against each defendant, on an individual basis. Following a County Court ruling should either party wish to appeal the decision this appeal would be heard in the High Court.

2.1.2 Costs associated with the court case will be on the equity scale. County Court costs should be capped at approximately £4,000 per party to the proceedings (per defendant) for the first day, and £1,200 per defendant for every day thereafter. Further legal costs are estimated at £5,000 for proceedings lasting for one day, and £3,000 for each subsequent day.

2.1.3 If five landowners did not consent to the route being asserted as a PROW the costs in the County Court, for a process lasting 2 days, would therefore be £34,000 (£20,000 court costs for the first day, £6,000 court costs for the second day, £5,000 legal costs for the first day and £3,000 legal costs for the second day).

2.1.4 If an appeal were to take place to the High Court, following the County Court proceedings, costs would be in the same magnitude as those experienced in the County Court.

2.2 Responsibilities of Council in relation to PROW

2.2.1 The Council has a duty to:

- Assert, protect and keep open and free from obstruction any PROW
- Compile and preserve maps of the rights of way in its area
- Signpost paths, where necessary, to help anyone who does not know the area
- Contribute at least a quarter of the cost of maintaining stiles and gates

Aside from that, should the Council so decide to, it also has the powers to:

- Maintain any PROW
- Authorise the erection of new stiles and gates

2.2.2 The onus does not fall on the Council to maintain the PROW but if the Council does decide to maintain the PROW, the Council will then become responsible for the Public Liability of the route. If not, the landowner will be responsible for liability.

2.2.3 The standard to which a PROW needs to be maintained is minimal, particularly in rural areas – only enough so that those who are reasonably fit in light active gear can easily pass. However, if the Council does agree to take on responsibility of maintenance there are wider obligations about visitor safety and so this standard may not be acceptable.

2.2.4 Regardless if the Council agrees to maintain or not, the Council has a duty to ensure the landowner doesn't intentionally block the PROW. If he/she does, the Council must remove the obstruction. It should agree works with the landowner but if agreement can't be met, then legal advice may need to be sought.

2.3 The next steps in the asserting the Green Road as a PRow were outlined in the Regeneration and Community Committee report in June 2020. These included:

- Review the list of landowners to establish that no details have changed since the Council were last in contact;
- Personally contact each landowner to inform them that the Letter of Claim for assertion of the Green Road as a PRow is on its way. In this way landowners will not be surprised by inclusion in the letter of the prospect of being taken to Court. This process could be completed in a number of weeks;
- Issue Letter of Claim to landowners and allow a period of up to 4 weeks for return.
- For those who do not agree with the proposed assertion of the Green Road as a PRow issue court proceedings to the County Court;
- Await the cases to be heard in the County Court - this could take a period of 6-12 months from the date of lodgement.

3. Resource Implications

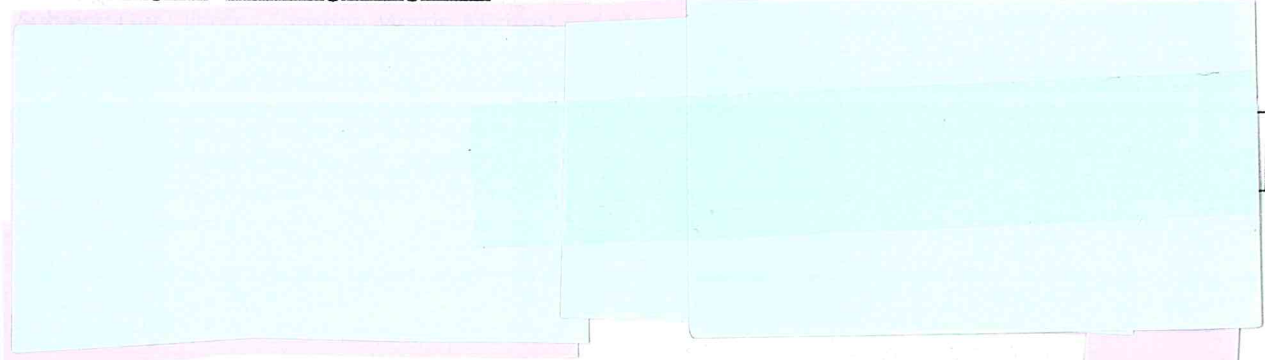

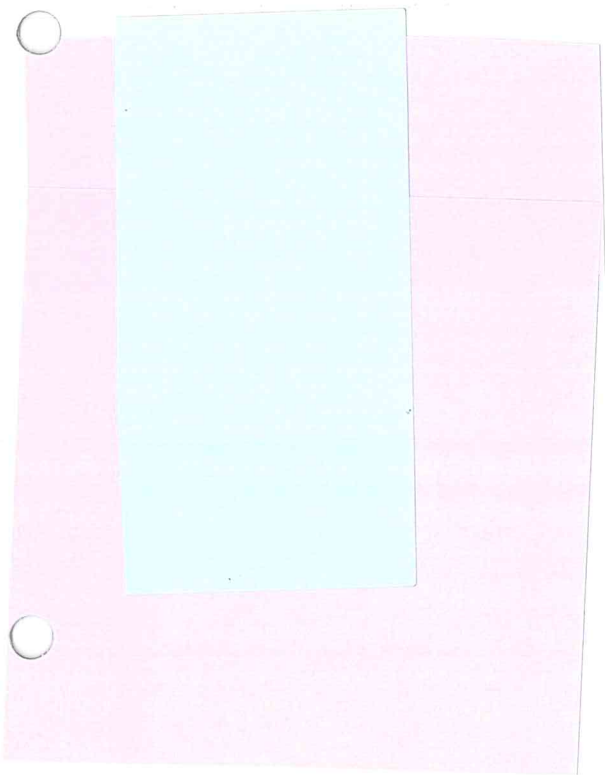

Our Clients –

We refer to the debate which took place at the Regeneration and Community Committee on 9 June 2020 in respect of the alleged public right of way over land described as the "Green Road", near Greencastle.

As previously advised, we act for the above-named clients, all of whom object to Fermanagh and Omagh District Council's (FODC) proposed assertion of this so-called right of way and whose intention it is to resist any such assertion, which has been clearly documented. The reference at paragraph 3.1.2 of the written report to the Regeneration and Community Committee on 9 June to "potential costs" of issuance of proceedings in the County Court is, in our view, misleading as Council officers had clear notice that, should the Council proceed with the proposed assertion, costs of proceedings are inevitable and not merely potential.

Indeed, the strength of opposition on the part of our clients and also on the part of other land owners is such that the costs of proceedings could be many hundreds of thousands of pounds. In this current climate of financial uncertainty and pressure on public finances, we welcome the decision by the Committee to have the matter reconsidered to determine whether the Council should get involved in this at all.

We now wish to set out a number of factors which we believe should be taken into consideration:
