Green Road (Greencastle to Rouskey) PROW Assertion

As you will be well aware the above mentioned PROW assertion is currently work in progress by your Countryside Officers ably assisted by Fermanagh & Omagh District Council's legal staff.

I am writing to state my deep disappointment and frustration at the apparent lack of will by Fermanagh & Omagh District Council to progress this investigation to the formal assertion stage. This process is now almost three years old with initial points being raised with Council officials in January 2016.

For clarity, it is important to note that during this time Council have:

- Responded to initial letters from local residents.
- Carried out evidence gathering.
- Sought legal opinion on "The Access to the Countryside (Northern Ireland) Order 1983" in relation to this matter.
- Sought the opinion of a QC to proceed to Assertion in the County Court.
- Responded to FOI requests from many different stake holders.

My frustration lies in the fact that following all the above coupled with the fact that Fermanagh & Omagh District Council have taken the unprecedented step of making all information and correspondence available in relation to the Green Road accessible via your website, the process appears in limbo since Council took the unusual step of seek a second Senior Counsels opinion in July 2018.

You will be only too aware of the widespread fears within my community that delays in this process could be viewed as helpful and of benefit to Dalradian Gold Ltd. in their attempt to secure planning permission for a Industrial Mineral Processing Plant on Crockanboy Hill outside the village of Greencastle, these fears are real and without being cynical, it is hard to defend Council's position when your staff wrote to the landowners whose land the assertion will effect in early January 2018 stating that this matter will go before Council in March 2018 for formal approval following which a PROW assertion will be sought to put the matter beyond legal doubt. This letter stated that in the view of Senior Counsel Fermanagh &

Omagh Council would be taking this matter to the County Court for Formal Assertion. The formal approval was proposed to go before Council on a number of previous occasions, only to be pulled from the agenda at the 59th minute of the 11th hour with no reason or clarity given to Party Councillors across the spectrum other than Council officials and your legal team needed more time! These unacceptable delays can lead to accusations from the public of Councillors and senior Officials not giving the concern of a rate payers and the issue due thought and respect.

It must be noted from your September minutes that opinion would be sought and offered by your November Regeneration and Community committee meeting which is set to take place on Tuesday 13th November but again the issue is not listed for discussion or consideration on the agenda which can be viewed on the Councils website! I accept the fact that the legal system moves slowly but 3-4 months seems very slow indeed for a matter in which stakeholders and many local residents have provided evidence and maps which show the route of the Green Road going back hundreds of years, this evidence includes maps, written testimony accompanied by pictures, a professional report as well as local residents accompanying your staff on a walk of the Green Road. We must also be minded of the fact that Council have investigated this route over thirty years ago and must have had reason to feel a potential PROW route existed then, as they placed a picnic bench on the route to allow hikers a resting spot, whilst they hopefully were enjoying superb views of our beautiful countryside. I have no doubt you will have viewed these reports in considerably detail as part of this investigation.

Can I respectfully request that you will raise this matter before Council at the earliest possible opportunity and secondly, I am assuming that you will be able to supply me with firm commitments on Senior Counsels opinion and a definitive timeline on bringing this PROW investigation to the Formal Assertion stage within the **next 21 days?** I sincerely hope that this will be the case so as to avoid further legal angles being explored which will only result in additional expense to Council and ultimately rate-payers as well as continued time constraints and pressure on local civil servants!

To conclude, I would like to finish by reminding you of the text in the letter to landowners in January 2018 which stated - In stating the evidence that is available about each route, the only test Council is able to apply is "does a public right of way – i.e. a right of passage already exist over this line?" If it does then Council has a duty to assert the path. The maxim is: Once a highway, always a highway.

Thank you for your correspondence.

There are two separate matters, albeit linked, in your correspondence and I will deal with each separately.

- 1) At the Council meeting last Tuesday we informed members that the papers are still with the QC and we are pressing for the opinion ASAP. I can assure you that it will be reported to the Council at the first appropriate meeting after we receive it. I totally refute any suggestion of an unnecessary stalling. Whatever decision the Council takes could be subject to Judicial examination and therefore we are ensuring that when the Council takes its decision it does so based on the best legal advice. That, in my view, is in everyone's interest.
- 2) The Council has a statutory duty to commence enforcement action when a breach of Planning Policy or Planning Conditions come to its attention. The GPO defender's camp and the placing of anti gold mining posters on BT property were both investigated in relation to breach of planning policy. It was on this basis alone that enforcement action was commenced.

Anyone is entitled to participate in legitimate protest as long as it is not in breach of any statutory provision.

I am also taking this opportunity to raise with you concerns about some comments from individuals in response to postings on the Greencastle Peoples Office facebook. These comments refer to Council officers in the following ways

'Brown envelopes for council bigwigs may be in order to silence protesters'

'Could be time for someone to expose their own planning office corruption during the building boom.'

I would be grateful if you could confirm your position in relation to these remarks and clarify what action you propose to take as far as they relate to content on the Facebook account of Greencastle Peoples Office. I trust that you will be in a position to refute these remarks and to have them taken down.

- i) I contact you once again to seek clarification on FODC's position on the Green Road and confirmation of its PRoW status. Has the legal opinion been received by Council and what is the timetable for moving these matters forward? The unnecessary stalling appears only to delay confirmation of the PRoW and allow Dalradian's proposal to gain traction.
- ii) News that FODC Planning is actively pursuing action against the defenders' camp, the Greencastle People's Office (GPO) has sent shock waves through the community to the extent that there was a large gathering of families and individuals (on Sunday afternoon 11th November) at the site, where Dalradian propose to locate their processing plant and toxic waste dump. People gathered to express support for the GPO at this time. There appears to be within Council an unreasonable tendency that would remove from the public the right to protest against the Dalradian proposals. People remember the move from within Council to ask BT to remove anti goldmining posters from telegraph poles, expressing people's objections to water, air and land pollution by toxic mining. There is a feeling out there that whereas Council is particularly reluctant to take action against Dalradian that there is no such hesitation regarding taking action against local people whose only crime is seeking to protect the health and well being of our children and grandchildren. We are not the ones proposing to introduce tonnes of cyanide into the AONB with all the attendant risks. We are not the ones proposing to discharge mercury, lead, arsenic, cadmium, arsenic,.....sulphuric acid etc into the air and into the Pollanroe Burn. Council's proposal to act against the Greencastle People's Office stands in start contrast to action by statutory authorities regarding the Twadell scenario.

I request that the relevant Committee and management ensure urgent clarification to avoid unnecessary stress and annoyance in the community.

Thank you for your letter dated 11 November 2018 regarding the matter as above.

I understand your frustration at the length of time this investigation process has taken however I can assure you that this is not due to any lack of will, by the Council, to have the process completed. The Council has a duty to carry out a full investigation of the matters pertaining to the assertion, or not, of a Public Right of Way (PROW). The process has been prolonged by a number of Freedom of Information (FOI) requests and requests for more time to be permitted to provide further information.

Indeed, as you state in your letter, it was proposed to finalise the process in March 2018 however the FOI requests and requests for more time to be permitted to provide further information came into play.

The Council has a duty to accept all evidence and the legal advice provided to the Council was that it should do so and permit the additional time for this evidence to be provided.

Since the first Barrister's opinion a considerable amount of information has been submitted, in fact the volume of material is evidenced by the material uploaded to the website. The Council took the decision to upload this material to inform all the stakeholders of the process and the complexity of the situation.

While, as you state, there is evidence and maps provided by the stakeholders and local residents which supports the assertion of a Public Right of Way there has also been evidence supplied by stakeholders and local residents which opposes the assertion of a PROW. Whatever decision the Council takes could be subject to judicial examination and therefore we are ensuring when the Council takes its decision it does so based on the best legal advice.

While the legacy Omagh District Council did start the investigation into the route many years ago our records show that this matter was not brought to a conclusion at that time.

In relation to your request that this matter will be brought before the Council at the earliest possible opportunity may I sincerely assure you that I have been trying to do this and will continue to do so. We have been informed that the Barrister's opinion will be provided to the Council by the end of this month (November) and the Councillors have been informed of this. The opinion will then be reported to the next appropriate Committee meeting for consideration.

In relation to your final paragraph, I again confirm that the Council has to fully consider all of the evidence provided i.e. both for and against assertion and in this particular case there is considerable new evidence provided for both for and against assertion. It is therefore necessary for the Council, based on legal advice, to get a Barrister's opinion on all of the evidence and to advise the Council accordingly. We cannot provide any formal commitment on a timeline for assertion, or not. There are a number of factors outside our control that could impact on this however we will be seeking to complete the process as quickly as possible.

I hope that this is of help in confirming where the process is at present.



Just under 30% of the Green Road is well maintained by the local farmers, and less than 30m has been subsumed into a domestic garden at one point and being reclaimed for rough pasturage at another.
Where the gradient of the land allows, there is clear sight of the Green Road along the horizon. The road is generally bound by post-and-wire fences on both sides, and a drainage channel on the north side.
Figure 1 below, outlines the presence and location of impedances to movement which includes gates, fences and steams. It also shows where existing tracks intersect the Green Road. The route is accessible on foot and although impedances add an additional obstacle, it is not surmountable.

Request for Disclosure of Information under the Freedom of Information Act 2000

I refer to the response dated 9th January of the Council's FOI team to our email dated 8th January 2019 seeking disclosure of all documents that were made available to members before or at the meeting of Council which took place on 4th December 2018, relating to a proposal to assert a public right of way at lands near Greencastle. Its response was that the report that went to Council on 4th December 2018 is confidential and was withheld under the Local Government Act (Northern Ireland) 2014 Schedule 6, Part 1 Item 5 - Information in relation to which a claim to legal professional privilege could be maintained in legal proceedings. This letter constitutes our request for an internal review of that decision.

The Information Commissioner's Office has produced guidance on the use of the Legal Professional Privilege qualified exemption. In the current context, litigation privilege cannot apply as the report in question was not prepared for the purpose of providing or obtaining legal advice about proposed or contemplated litigation.

We acknowledge that legal advice privilege may apply to some or part of the documents that were made available to members but this exemption will be of limited application. It is therefore incumbent on you to review the documents in detail and assess which elements constitute advice given in a legal context. All elements not constituting such advice should be disclosed. Any elements constituting legal advice will also need to be considered carefully in the context of the public interest to assess whether the public interest in maintaining the exemption outweighs the public interest in disclosure.

The purpose of the report was to seek Members' approval to grant funding of £3,030 towards the Red Squirrels United Project to enable Ulster Wildlife and the West Tyrone Red Squirrel Group to purchase equipment to gain a better understanding of the current distribution of red and grey squirrels within the Council area, as detailed at Paragraph 1.5 of Paper M.

In response to Members queries, the Director of Community, Health and Leisure stated that:

The Director of Community, Health and Leisure stated that, following the Council's decision to assert that the Green Road, Greencastle was a Public Right Of Way and to have this vindicated in the County Court, it was necessary for the Council to have the assertion statement and the accompanying map, attached at Appendix 1 of Paper O, formally recorded within the Minutes.

In response to Members' queries, the Director of Community, Health and Leisure stated that:

- The assertion had taken place at the Council Meeting on 4 December 2018, however, to progress the matter, the Council required a record of what was asserted and this was provided within the description and accompanying map which detailed the description, the line, the length and the location of road to be asserted;
- Any interested parties to receive a copy of the description and the map, as
 detailed with the report, included everyone who was involved in the process
 previously including those who showed an interest, provided evidence or
 returned information:
- There was a record of Public Rights Of Way within the Council area and clarification of where the records were held would be provided;
- A report on the number and location of Public Rights Of Way within the Council area would be presented at a future Regeneration and Community Committee meeting;
- All information relating to the assertion of the Green Road Public Right Of Way would be circulated to all Members;
- The Council's legal opinion could not be made publicly available, however, it had been circulated to all Members:
- If the assertion of the Green Road Public Right of Way was confirmed in the County Court, there was an onus on the Council to investigate the aspect of insurance;
- The maintenance of and the insurance relating to the Green Road Public Right Of Way was dependent on the decision taken in the County Court, and it was preferable to await this decision and speculate on thematter;
- When a possible Public Right Of Way was brought to the Council's attention, it had a statutory responsibility to investigate it and to act on the evidence provided. Any member of the public could request that the Council undertakes an investigation;
- The first engagement with the Council in relation to the Green Road,
 Greencastle had been in the legacy Omagh District Council term, followed
 more recently by correspondence received from Dfl Roads regarding the
 proposed abandonment at Mullydoo Road, Greencastle. Landowners and
 Community Groups in the area had also contacted the Council to advise that
 there was a Public Right Of Way on the Green Road;
- The assertion process had taken some time due to the requirement to collect all the necessary evidence and to obtain legal opinion;
- The decision could be challenged in the Court and additional cost implications could arise; and
- The Council would be apprised at each stage until the legal process of assertion was completed.

- 1. The complainant has requested information from Fermanagh and Omagh District Council ("the Council") in relation to the investigation process for the assertion of a public right of way in County Tyrone, Northern Ireland. The Council disclosed the requested information, with some information redacted under section 40(2) of the FOIA.
- The Commissioner's decision is that the Council wrongly handled the request under the FOIA. In failing to consider the request under the EIR, it breached the requirement of regulation 14 of the EIR.
- 3. The Commissioner finds that the Council was entitled to rely on regulation 13 (personal information) of the EIR to withhold the withheld information. No steps are required.



Background to the request

- 4. In 2010, Dalradian Gold Limited (DGL) acquired land at Curraghinalt, Omagh, County Tyrone, and in 2014 was granted planning permission for an exploration tunnel investigation on that land. A further planning application, for an underground mine, was lodged by DGL in 2017. The project, if approval is granted, is set to last 25 years and DGL has estimated that £750 million will be spent on it.
- 5. In 2016, the Council received correspondence calling for it to use its statutory powers of investigation to assert that there is a Public Right of Way over the Green Road from Greencastle to Rousky, County Tyrone, which would be highly significant as this is in the vicinity of the proposed Dalradian gold mine operation. The complainant has requested information in relation to the Assertion of Public Right of Way investigation being carried out by the Council.

Request and response

- 6. On 12 March 2018, the complainant wrote to the Council and requested information in the following terms:-
 - 1. Correspondence from residents received in February 2016.
 - Correspondence to the 25 stakeholders identified at paragraph 2.13 of Summary of the Assertion Report dated November 2016.
 - 3. Copies of all other correspondence, internal file notes, internal e-mails, reports, attendance notes, from January 2016, not already disclosed to us between July 2017 and January 2018.
- 7. The Council responded to the complainant on 12 April 2018, disclosing the requested information in parts 1 and 2 of the request with redactions and citing the exemption under section 40(2) (personal data of a third party) as a basis for those redactions. It refused to disclose the information requested in part 3, citing section 12(1) (cost limit) as a basis for non-disclosure.
- 8. The complainant was not satisfied with that response and requested an internal review, the result of which was provided to her on 3 May 2018. The reviewer determined that the complainant should be provided with the information requested in part 3 of the request,



subject to redactions, and upheld the original decision in respect of parts 1 and 2 of the complainant's request.

Scope of the case

- 9. The complainant contacted the Commissioner on 30 May 2018 to complain about the way the Council handled part 2 of her request for information.
- 10. The Commissioner has considered the Council's handling of part 2 of the complainant's request, specifically the Council's redaction of names and contact details from the correspondence it disclosed in response to part 2 of the request.
- 11. During the Commissioner's investigation, she reconsidered the request and the withheld information and concluded that the information was environmental and that the Council should have dealt with the request under the Environmental Information Regulations 2004 (EIR).

Reasons for decision

Access regime

- 12. As set out above, the Council responded to the request under the FOIA. However, it is the Commissioner's view that the request was for environmental information and that the Council ought to have dealt with it under the EIR rather than the FOIA.
- 13. Regulation 2(1) of the EIR defines environmental information as being information on:
 - "(a) the state of the elements of the environment, such as air and atmosphere, water, soil, land, landscape and natural sites including wetlands, coastal and marine areas, biological diversity and its components, including genetically modified organisms, and the interaction among these elements;
 - (b) factors, such as substances, energy, noise, radiation or waste, including radioactive waste, emissions, discharges and other releases into the environment, affecting or likely to affect the elements of the environment referred to in (a);
 - (c) measures (including administrative measures), such as policies, legislation, plans, programmes, environmental agreements, and activities affecting or likely to affect the elements and factors



referred to in (a)...as well as measures or activities designed to protect those elements..."

14. The Commissioner has considered the wording and focus of the request. As it is regarding the legal process surrounding the assertion of a public right of way, the Commissioner now considers that it is a request for information which is a measure as set out in regulation 2(1)(c) which is likely to affect or protect the elements of the environment. Therefore, the Commissioner considers that the request was for environmental information as defined by regulation 2(1) of the EIR.

Regulation 13 - personal data of third parties

- 15. The Commissioner considers that the arguments provided by the Council in respect of its application of section 40(2) of the FOIA to the withheld information are comparable to what would be required when considering the application of regulation 13. She has therefore used her discretion and considered them below rather than requiring the Council to issue a fresh response in line with the EIR; this is to ensure that the complainant is not disadvantaged by any further delay.
- 16. In this case the Council cited section 40(2) in respect of the redacted information in part 2 of the complainant's request. The Council confirmed that it was applying section 40(2) in conjunction with the condition listed in section 40(3)(a)(i). This applies where the disclosure of the information to any member of the public would contravene any of the principles of the Data Protection Act 1998 (the DPA). The DPA has since been superseded by the General Data Protection Regulation 2018 (GDPR) and the Data Protection Act 2018, however the 1998 Act was still in force at the time of the complainant's request and this has therefore been considered under the 1998 legislation.
- 17. Regulation 13(1) of the EIR provides that information is exempt from disclosure if it is the personal data of an individual other than the applicant and where one of the conditions listed in regulation 13(2)(a)(i) and (ii) is satisfied.
- 18. In this case the relevant condition is contained in regulation 13(2)(a)(i) as the Council's position is that disclosure of this information into the public domain would be unfair and unlawful, which would contravene the first data protection principle as set out in the DPA.



- 19. The Council states that, following two preliminary site visits in June and August 2016, 25 different stakeholders were contacted as secondary evidence groups on 2 and 3 September 2016. Each group was issued with an evidence form and a map for them to demonstrate where, if at all, they felt the public right of way was located. The Commissioner has viewed the information detailing correspondence to the stakeholders.
- 20. The Commissioner is satisfied that the information in question is the personal data of individuals other than the requestor. This is because the individuals can be identified from their names and contact details on the correspondence. The other information which has been withheld by the Council is the names of the organisations which the individuals represent, save for the names of organisations which are public authorities, in which case the names and contact details of the individuals representing those organisations were also disclosed. The Commissioner does not usually consider the names of organisations to constitute personal data, however in this case the organisations whose names are being withheld are small, voluntary groups, and in some cases individual landowners. Disclosure of which of those groups received and responded to correspondence from the Council regarding the public right of way could lead to identification of the individuals who received the correspondence and responded on behalf of the small voluntary groups. The Commissioner has therefore gone on to consider whether disclosure of this information into the public domain would be unfair.
- 21. When considering the fairness and the first data protection principle the Commissioner has taken the following factors into account:
 - the individuals' reasonable expectations of what would happen to their information;
 - whether disclosure would cause any unnecessary or unjustified damage or distress to the individuals concerned (i.e. the consequences of disclosure); and
 - whether the legitimate interests of the public are sufficient to justify any negative impact to the rights and freedoms of the individuals as data subjects.



- 22. The Commissioner has first considered individuals' expectations. The Council states that the individuals in question, both the landowners and those who represented the small voluntary groups, would have a reasonable expectation that the Council would keep their personal information in confidence and not disclose it into the public domain in this specific context. A representative of one of the small voluntary groups indeed specifically requested anonymity in relation to the public right of way consultation process.
- 23. The Council stated that, as part of the Assertion of Right of Way process, the identities of the 25 stakeholders will be disclosed as part of the discovery process, as the Assertion process requires a County Court determination. However, at the time of the request, such a determination would have been at least 18-24 months away so, whilst the stakeholders would have been aware of future disclosure, they still had a reasonable expectation that the Council would keep their details confidential at the time of the request.
- 24. The Council states, and the Commissioner is otherwise aware, that both the proposed DGL gold mine and the interlinked public right of way issue have divided the community and caused heightened tensions. Some people believe very strongly that the gold mine will have an adverse environmental impact on the area, whilst others believe that it will be of great economic benefit, creating jobs and increasing tourism to the area.
- 25. The Council has expressed serious concerns about the possible consequences of the information being released, and has provided evidence of harassment of individuals over their views regarding the gold mine. The disclosure of a map drawn up by DGL, pinpointing homes in the area with the initials of the 'head of house' beside them, has caused locals on both sides of the argument to fear for their safety. If the information was to be disclosed, the individuals and organisations concerned would be likely to be very distressed and fear reprisals.
- 26. The Commissioner has next considered whether there is any legitimate interest in disclosure of the information which would be sufficient to justify the negative impact of disclosure on the data subjects. The Commissioner accepts that this is an area of great public interest, and that disclosure of the information would be of legitimate interest to both the complainant and the wider public. However, all papers regarding the ongoing planning application and assertion of public right of way are uploaded regularly onto the Council's website,



with appropriate redactions made and explained. The legitimate interest of the public can be served by reading the information available at www.fermanaghomagh.com/your-council/freedom-of-information, which can be accessed free of charge.

27. The Commissioner has concluded that, whilst there is some legitimate interest in disclosure of the information redacted under regulation 13(1) of the EIR, this is not sufficient to justify the distress which would be caused to the data subjects by disclosure, particularly as the legitimate interest can be served in large part by accessing the information available through the link above. The Commissioner therefore considers that regulation 13(1) of the EIR applies to the withheld information.

Regulation 14 - refusal to disclose information

- 28. In the circumstances of this case the Commissioner has found that, although the Council originally considered this request under the FOIA, it is the EIR that actually apply to the requested information.
- 29. In these circumstances the Commissioner believes that it is appropriate to find that the Council breached regulation 14(1) of EIR which requires that a public authority that refuses a request for information specifies, within 20 working days, the exceptions upon which it is relying. This is because the refusal notice which the Council issued (and indeed its internal review) failed to cite any exception contained within the EIR as the Council actually dealt with the request under FOIA.



Right of appeal

30. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:


