The default target for paying invoices, where no other terms are agreed, is 30 days.

Note: 30 days is 30 calendar days and 10 days is 10 working days

During the period 01 April to 30 June 2022 the Council paid 3540 invoices totalling £10,245,956.46

The number of number of disputed invoices was 69

The Council paid 3481 invoices within 30 days

The Council paid 3254 invoices within 10 days

The Council paid 59 invoices outside 30 days

The average number of days taken to pay suppliers during this period was 9 days
