### 1. Relevant Background and Introduction

- 1.1 The Census 2021 was undertaken on 21 March 2021. A series of results have now been published. The latest publication, on 21 February 2023, provides population and household statistics for areas within local government districts.
- 1.2 Data have been made available for District Electoral Areas, Super Data Zones and Data Zones. The latter two are new geographies, replacing Wards, Super Output Areas (SOAs) and Small Areas.
- 1.3 This paper provides an overview of the data, the trend and the new geographies.

### 2. Key Issues

- 2.1 On Census day in 2021, there were 116,812 people living in 45,715 households in Fermanagh and Omagh. This was a 3.2% increase from 2011, or 3,651 additional people.
- 2.2 At a DEA level, there has been a noticeable trend in terms of urban / rural growth, with rural areas growing faster. Erne West (5.9%) and Erne East (5.4%) were the two

fastest growing DEAs in population terms. Conversely, Enniskillen (1.7%) and Omagh (2.2%) grew comparatively slower in percentage terms. Table 1 below provides an overview of the data:

- 2.3 The number of households in Fermanagh and Omagh has grown faster in percentage terms than population. In 2021, there are 10% more households than there were in 2011. This demonstrates the falling size of households across Fermanagh and Omagh.
- 2.4 At the DEA level, the trends are similar for households as they are for population, with rural areas growing faster. Table 2 below provides an overview of the results:

- 2.5 Super Data Zones (SDZs) are the new geographical tier below DEAs. They replace Super Output Areas (SOAs). (The 2021 Census will not be published at SOA level).
- 2.6 There are 49 SDZs in the Fermanagh and Omagh District and 850 in Northern Ireland. The naming convention is linked to the DEA. For example, Mid Tyrone\_A, Mid Tyrone\_B etc.
- 2.7 Data Zones (DZs) sit as a geographical tier below Super Data Zones (SDZs). They replace Small Areas (SAs). (The 2021 Census will not be published at SA level).
- 2.8 There are 233 DZs in the Fermanagh and Omagh District and 3780 in Northern Ireland. The naming convention is linked to the DEA and the SDZ. For example, Mid Tyrone\_A1, Mid Tyrone\_A2, Mid Tyrone\_B1 etc.
- 2.9 The new tiers are coterminous with DEAs but not with the older SOAs or SAs.
  Appendix 1 provides a map of the new SDZs. Appendix 2 a map of the new DZs.
  Appendix 3 shows the overall picture of the DEAs, SDZs and DZs.
- 2.10 Unfortunately, there has been no 2011 Census data published for the new geographies. Therefore, a comparison over the decade is not possible.
- 2.11 Clarification has been sought from NISRA on whether there are plans to retrospectively publish SDZ and DZ data for the 2011 Census, and whether (or when) all lower tier statistical publications will now follow this new geographical structure.
- 2.12 The next Census 2021 publication is scheduled for 21 March 2023 and will include the following topics at the local government district (LGD) level:
  - marital and civil partnership status
  - household composition and living arrangements
  - sexual orientation
  - qualifications
  - labour market
  - travel to work or study
  - communal establishments
  - migration.






# Enniskillen DEA SDZ 2021




# Erne East DEA SDZ 2021






