Role of the Planning Department


- Must prepare a Local Development Plan





Local Development Plan - Local Policies Plan

Sets out Council's local policies and site-specific proposals in relation to development and use of land.

- Call for Sites
- Strategic Housing and Land Availability Assessment
 - Suitable
 - Available
 - Deliverable
- Housing Need
- Allocate and Zone land for housing (phase 1 & 2) and Housing Policy Areas



Planning Performance Locally

Local Planning Improvement Programme

- Validation Checklist
- Detailed validation process
- Review of key operating protocols
- Pre –Application Discussions



Planning Performance Locally


- 2024/2025 – Published Statistics
 - Local – 10.2 weeks (Target 15 weeks)
 - Major – 24.5 weeks (Target 30 weeks)
 - Enforcement – 83.3% (Target 70%)
 - Approval rate – 96.9% (NI Average 94.5%)
- 2025/2026 – Q1 - Published Statistics
 - Local – 7.6 weeks
 - Major – 10 weeks
 - Enforcement – 87.5%
 - Approval rate – 97.1% (NI Average 94.6%)
