2) Acquisitive Crime inc. Rural Crime

The first meeting did not achieve quorum so while there was useful discussion amongst those present no actions were forthcoming.

Members queried the low response to register interest in either of the two subgroups; some suggestions for encouraging membership were discussed.

Road Safety Quiz for Primary Schools:

Cllr Thomas O'Reilly thanked the Partnership for the recent Primary Schools Road Safety Quiz and commented on the importance of raising awareness of road safety for all users.

Speed Indicator Device (SID) Deployment:

Cllr Thomas O'Reilly asked the Partnership to explore purchasing permanent Speed Indicator Devices in addition to the four mobile devices currently owned by the Partnership. The PCSP Manager provided some information on the process for deploying the mobile devices and the role of the Department for Infrastructure and Roads Policing. She further updated that the Joint Committee had issued a directive that SIDs are no longer considered eligible expenditure for Joint Committee funding. Members agreed of the benefits of SIDs in reducing speed and raising awareness of road safety and queried the Joint Committee directive.

Recommended:

1. That a report exploring the purchase of additional SIDs be brought to a future PCSP meeting.

FODC Corporate Plan 2024 - 2028 (Draft)

The PCSP Team Leader informed the meeting that Fermanagh and Omagh District Council has launched the public consultation phase for its draft Corporate Plan, outlining the priorities that will guide the Council's development and delivery until 2028.
