## PC 20/24 Six month report on the delivery of the Local Policing Plan

To receive a report on the delivery of the Local Policing April – September 2024.

Superintendent Robert McGowan (PSNI) updated Members on the Local Policing Plan for G District.

Keys points noted:

- The success of rural crime engagement projects and thanked Crime Prevention Officer Joe Keys for his continued community engagement work.
- Satisfaction rates and 10 updates once a crime has been reported is currently 97.8% highest level compared to service wide area.

- Outcome rates have increased with G District now outperforming other districts with potentially the highest clearance rates in the United Kingdon.
- Noted the success of Neighbourhood Watch and reaccreditation of schemes.
- The success of the PSNI work experience programme and youth engagement work with local partner Blue Green Yonder.
- Rise in fatal Road Traffic Collision (RTC's) is a huge concern and will be focusing efforts on safety and drink/drug driving coming into the holiday period.

Superintendent Robert McGowan (PSNI) also updated Members on the refurbishment of Omagh Custody suite which has been delayed however is ongoing with no clear date as yet for completion.
