PCSP 72/24 **A.O.B.**

1. Nicola McSherry (NIFRS) updated Members on the current NIFRS recruitment campaign for On-call Firefighters, open nights will be held in local stations throughout the district.

2. Nicola McSherry (NIFRS) provided an update on a query raised by Cllr Keith Elliott at a previous PCSP meeting regarding how NIFRS prioritise flooding incidents.

NIFRS will respond to flooding incidents where it is deemed there is a 'risk to life'. In non-life risk situations NIFRS will not be committing resources and would encourage residents in high risk flood areas to work with relevant agencies to prevent re-occurrence and prepare in advance.

- 3. Chief Insp. Scott Fallis updated Members on the stop and search powers and requested Members to seek feedback from their communities. After discussion, members queried what the exact figures were for the area.
- 4. Cllr Thomas O'Reilly sought an update from PSNI on Omagh custody suite opening following refurbishment. Superintendent Robert McGowan (PSNI) advised that a preliminary date of 02 October 2025 has been given.
- 5. PCSP Manager Carol Follis updated Members on the following:
 - Recruitment of reserve PCSP Independent Members is now complete.
 - Reminder of the forthcoming Youth Justice Agency (YJA) visit on the 24 February.
 - Following feedback from Members a PCSP Members social event is scheduled for 20 March 2025 to allow Members to network outside of PCSP activity.
