Neighbourhood Watch Schemes

PCSP 20/25

PCSP Community Liaison Officer Alan Crooks updated Members on ongoing Neighbourhood Watch schemes in the district Members were presented with three new schemes for accreditation and twenty-seven for reaccreditation across the district. With approval all Members agreed to the new accreditations and reaccreditations.

Members received a presentation on PCSP Quarter 1 Activities. Highlights included Emergency Services Day in Omagh, Bikesafe, Omagh Show, Scam Awareness events, Interagency meetings and PCSP Grant Aid support funded projects.

PCSP 22/25 A.O.B.

1: Drug Seizures in the district

The PCSP Vice-Chair requested an update from Police on recent drug seizures within the district and queried whether there had been an increase in activity and what actions were being taken.

Inspector Dodds reported that drug seizures and Border Force detections had increased, not only within the district but across the island of Ireland. He advised that Police are working in partnership with An Garda Síochána conducting regular intelligence-led patrols, specifically targeting high-level dealers to disrupt supply. He further noted that social media platforms are increasingly being used in the supply of drugs.

Neighbourhood Policing teams continue to engage with schools, and the Public Health Agency to raise awareness of the risks associated with drug and alcohol misuse.

2: Burglaries in Enniskillen

Cllr Crawford requested an update on recent burglaries and vehicle thefts at two local housing estates in Enniskillen at the end of August.

Inspector Dodds advised that incidents had occurred in the Lough Yoan Road, Kilmacormick, and Hillview Park areas, where multiple houses and vehicles were targeted. He reported that two local gangs were identified as being involved, which aided the investigation through engagement and intelligence from residents. Arrests were subsequently made, and Police are confident in the evidence gathered.

Inspector Dodds further confirmed that additional patrols are in place, with community engagement meetings arranged alongside Neighbourhood Watch and Police teams to provide reassurance. Victims were kept updated throughout and expressed support for the prompt arrests made within two days. He thanked the local community for their assistance.

3: Action plan Task & Finish Group

Greg McMullan informed Members that he, along with the Chair and Vice-Chair, will form a Task and Finish Group to draft the PCSP Action Plan for the coming year. He noted that broad Member representation will be required to inform the Plan. Meetings will be scheduled during the day, and Members wishing to participate were asked to respond by Friday, 26 September.
