PC 10/25 **Local Policing Plan 2024-2025**

12 Month Report on the delivery of the 2024/25 Local Policing Plan.

Chief Insp. Scott Fallis updated Members on the Local Policing Plan for G District and thanked the Officers in the G District for their continued commitment and hard work over the past year.

Following the presentation, Chief Insp. Scott Fallis answered questions from the Members.

- Cllr Crawford noted recent incident in Omagh where a Police Officer
 was dragged up the road causing injury to the Officer.
 Chief Inspector Scott Fallis stated that daily reviews are conducted
 on assaults against officers. Comprehensive welfare support is in
 place and continuously monitored, and the recent increase in
 incidents is not currently a cause for concern.
- Chief Inspector Scott Fallis noted an increase in damage to duallanguage signage, particularly in the Omagh area. While no clear pattern has emerged from the analysis, the repeated vandalism is resulting in unnecessary costs for agencies due to ongoing replacements.

Cllr Crawford requested data on the number of signs damaged and the specific areas affected.

• The Vice Chair thanked Chief Inspector Scott Fallis for his report and raised a concern from a recent Children and Adult Safeguarding Protection meeting regarding the potential exploitation of children and vulnerable adults within the district.
Chief Inspector Fallis responded that this is not currently believed to be an issue. He noted that officers are actively engaging with care homes, and measures are in place for staff to report any concerning individuals visiting these facilities directly to the police.

• That PSNI present figures on damage to Dual Language signage at the next meeting.
