Chief Insp Graham Dodds and Sergeant Lauren McFarland.

Graham Dodds has returned to G District.as Chief Inspector for Performance & Standards in the Fermanagh & Omagh District.

Chief Insp Dodds delivered a presentation to members on Community Resolution Notices (CRN's).

Highlights included:

CRN's are a recognised Criminal Justice outcome and counted as a Criminal Justice Outcome and in crime clearance figures it is included. G District there is approximately 12% outcome is CRN's Is evidence purely evidence based which PPS verify.

Following the presentation member engaged in a Q&A session.

- Impact on reoffending ask CJ and if it can be shared
- With regard to repeat offending, a CRN cannot be given for same offence in a 12 month period.
- Statistical breakdown of CRN's issued to under 18 year olds and adults.
- Can statistics identify clusters of CRN's issued per area/town or wards.
- Drug awareness course uptake and outcomes

Recommended:

- Figures on statistical breakdown of CRN's issued to under 18's to be shared with Ryan McGee EANI
- 2. Ask Criminal Justice if stats on CRN's could be obtained by specific area to identify clusters.
- 3. Request outcomes of Drug and Alcohol awareness
- 4. Contact PBNI to deliver a presentation to PBNI staff on CRN's

PC 34/24 Members' Questions

1. Security alert to 9 schools in Northern Ireland

- Superintendent Robert McGowan updated Members on the Security incident at local schools on Monday 24 March and is still a live investigation.
- First time in Northern Ireland this has happened.
- Local Officers' early intervention deemed local schools could remain open after sweep of the building by Police and Staff.
- Threat was made via email to the schools overnight to pupils and staff.
- The threat did not come from the local area and working with the Metropolitan Police and enquiries are ongoing.
- Did not affect Police operations, extra patrols were placed to provide reassurance.

2. counterfeit notes in circulation. How do we recognise these? Aware of 2 incidents in G District and 1 incident in F District. Superintendent Robert McGowan informed Members of recent incidents person is using counterfeit notes to make small purchases to gain change.

As well as Facebook Marketplace cash transactions. Urged businesses to seek assistance and resources from Bank Of England have really detailed information on their website including videos, training materials, posters and guidance.

Contact 101 and report any suspicious activity.

Thoughts on self-appointed Paedophile hunters and if there are any in this area?

Crops up periodically some reports in the area, Urged not to take the law into own hands

Bring information to Police who have specialised officers and a Department who deal with this area. Anyone who is engaged in this type of activity have to be very careful. The Criminal Justice process is there and must be followed through.

Level of human error is involved and safeguards are in place. It can impeded Police investigations and urged if anyone has any information on Paedophile sexual offending need to bring it to Police and condone any vigilante activity.
