| Purpose of Report | To seek Member approval for the 2025-2026 Meeting Schedule |

1.0 Relevant Background and Introduction

It is necessary to develop and agree a meeting schedule for PCSP and Policing Committee meetings for the 2025-2026 financial year.

PCSP Standing Orders state that PCSP holds all its meetings in public; a minimum of four business meetings and a minimum of two themed meetings each year.

There are a minimum of four meetings of the Policing Committee each year. One meeting is the annual report from the District Commander detailing delivery of the Local Policing Plan for the previous financial year.

Members are advised that meetings of Task & Finish Groups will be called as and when necessary and will be held in person or on MS Teams as deemed most practical at the time. It may also be necessary from time to time to hold meetings outside of the schedule to facilitate guest speakers or to discuss and emerging community safety issue. Where this is the case the PCSP Manager will liaise with the Chairperson to make the necessary arrangements and give Members as much advance notice as possible.

2.0 Key Issues

The schedule details the PCSP and Policing Committee Meetings where the business of the PCSP will be conducted. Outside of this meeting schedule there will be a minimum of two events, venues to be determined, that promote the PCSP and partner organisations showcasing projects and activities. This approach is to increase awareness of the PCSP and an understanding of its role and that of partner organisations.

3.0 Recommendation

That the Partnership approves the 2025-2026 meeting schedule.
