The following terms and conditions of membership use are to be read fully upon joining. All terms and conditions are final and authoritative.

Castle Park Fitness Suite will be open during the following hours:

Monday – Friday – 10.00 am – 10.30 pm

Saturday 10.00 am – 6.00 pm

Closed Sunday and Bank Holidays. Holiday season opening hours will be determined at the time of the Holiday.

People wishing to become members of Castle Park Fitness Suite must complete the appropriate application form which must be submitted to the facility with the prescribed payment.

The monthly cash payment due date will be 30 days after commencement of the membership and will continue every 30 days thereafter.

Membership is non-transferable from person to person in the same family.

Unless expressly stated in the health questionnaire, the member acknowledges that he/she is in good health and not suffering from any medical condition.

Management shall annually determine the amount of the subscriptions and charges. A current list of all charges in force will be available at Reception and the list of charges as maintained by the management shall be regarded as authoritative and final.

The management reserves the right to terminate, without notice, a membership. It shall be at the sole discretion of the management whether or not all or part of the membership fee is refundable in such circumstances.

Cancellation of direct debit prior to official end date of membership (typically 12 months after original payment) will mean that the member will not be able to avail of direct debit membership at a future date.

All members who wish to cancel their membership must give one month's written notice to the Manager.

Management reserves the right to withdraw the use of any or all parts of the facility for the purpose of maintenance work, or any other work deemed necessary by the management.
