**DE03 Sustaining Rural Communities** 

#### **Details**

The plan strategy should take account of representations made during the Prepared Options Paper (POP) in which one of the main issues that emerged was the ability to sustain rural communities. In the Fermanagh Area Plan (FAP) in 2007, 11 communities were designated as 'Dispersed Rural Communities' including Cashel (where I grew up) and Boho (where I now live). The intention in designating those areas was to promote regeneration in those rural areas, and as far as I am aware that plan did help to promote regeneration and encourage planning permissions in those areas. I am deeply concerned that the draft plan seems to have ignored the earlier representations in the POP and FAP and is now asserting that the designation of Dispersed Rural Communities is no longer relevant. (p306 of the draft plan). These rural areas are of huge significance to the residents, schools, businesses etc in those areas and should be taken into account in any future strategy plan put in place by Fermanagh & Omagh District Council.

The FODC Community Plan states that Fermanagh & Omagh is primarily rural and a key challenge will be 'to ensure the continued vitality and sustainability of our rural communities' p5.I believe one way to achieve this would be to maintain the current Dispersed Rural Communities (which the draft strategy is planning to remove and ignore) and perhaps even designate additional rural communities - similar to the proposal by Mid Ulster Council

**DE03 Sustaining Rural Communities** 

#### **Details**

PPS 21 Policy CTY2 Development in Dispersed Rural Communities (DRC's) resulted in this policy provision taking precedence over the Area Plan. CTY2 has been utilised on several occasions (eg in Boho, when the playground was approved). PPS 21 outlines how rural areas display symptoms of economic and social disadvantage and how the Department identified and specifically designated DRCs to promote regeneration in these areas. Strategic Planning Policy Statement (SPPS) is silent on what is defined as a focal point. It further states that a regional strategic objective for tourism is to sustain a vibrant rural community. I feel the Draft Plan Strategy does not take full account of the policy and guidance contained in PPS21 or SPPS, and unfortunately seeks to undesignated DRC's rather than work to promote regeneration within them.

#### **Details**

The Fermanagh Area Plan (FAP) identified and designated 11 Dispersed Rural Communities. Although the Draft Plan Strategy refers to Rural Community Areas (p91) no community areas are designated in the Strategy. I would ask the Council to ensure that the 11 Communities identified and designated in the FAP are specifically named in the Strategy and included on the relevant maps. This designation will be important when applying for grants to bring much needed resources into these rural communities. Mid Ulster Council are giving consideration to designating more DRCs within their council district. The plans for Monaghan and Cavan County Councils also designate DRC's. In light of plans, policies and strategies of adjoining districts I do not understand why FODC has failed to designate the 11 DRC's in the plan strategy.

Given the failure of the Draft Plan Strategy to include and specifically designate Dispersed Rural Communities I do not feel the strategy can be flexible to deal with changing circumstances particularly with reference to rural communities. I am specifically concerned about ageing populations and isolation in rural areas, the increased need for people to live close to family members if possible to reduce the reliance on the health sector etc

### **Modifications**

I would like the Draft Plan Strategy Policy on Rural Community Areas adapted so that the 11 existing DRCs are identified and specifically designated in the Strategy with the scope to also include additional DRCsI think the Draft Plan Strategy needs to be more flexible to take account of the issues mentioned in the Community Plan eg ageing population. I would like FODC to acknowledge the work of neighbouring councils in particular with reference to dispersed rural communities
