



Local Development Plan 2030 Addendum to HRA Report: Habitats Regulations Assessment of the LDP Draft Plan Strategy

October 2020

Executive Summary

This document comprises an Addendum to the Draft Habitats Regulations Assessment (draft HRA) Report, October 2018, prepared in support of the Draft Plan Strategy and is one of the plan documents prepared for Fermanagh and Omagh District Council's Local Development Plan (LDP) 2015 -2030.

All Representations, including those regarding the HRA, received during the public consultation exercise held between 26 October and 21 December 2018, and the Council's response to them, are dealt with in the LDP Draft Plan Strategy Consultation Report.

Following consideration of the Representations received, the Council has recommended a number of 'Proposed Changes' to the published Draft Plan Strategy. These are can be found in the Schedule of Proposed Changes, published alongside this document. Some of these changes specifically address the recommendations of the draft HRA.

This report assesses these changes through the HRA process by firstly screening all the Proposed Changes to identify whether any would have a likely significant effect on any International sites. Where a likely significant effect is identified the need for appropriate assessment is considered. The findings are set out in Table 1.

It was found that the majority of changes proposed will have no conceivable effect on any international sites. On the contrary, some increase awareness of potential effects on International sites or otherwise strengthen the draft Plan Strategy in respect of protection of international sites. In reviewing those policies subject to change some were identified as requiring appropriate assessment to test and ensure that appropriate mitigation is incorporated to avoid adverse effects on site integrity of International sites.

This addendum highlights the effects that the Proposed Changes to the LDP Draft Plan Strategy have had in regard to the Draft HRA of the Draft Plan Strategy. The HRA will be added to and finalised following public consultation and independent examination of the draft Plan Strategy, then published alongside the adopted Plan Strategy.

1. Introduction

- 1.1 Fermanagh and Omagh District Council (The Council) is preparing a new local development plan for the District, referred to as the Local Development Plan 2030 (LDP). This will replace the existing plans and provide a revised framework to inform planning decision making and guide development. This report is an addendum to the draft Habitats Regulations Assessment (hereafter referred to as 'the draft HRA') which has already been carried out in respect of the draft Plan Strategy, as required under Regulation 43 of the Conservation (Natural Habitats, etc.) Regulations (Northern Ireland) 1995 (as amended).
- 1.2 This document forms an Addendum to the October 2018 HRA Report and identifies whether the outcomes of that report should be varied from those originally reported as a result of the Schedule of Proposed Changes (hereafter referred to as 'the Proposed Changes'). It focuses on the Proposed Changes and effects of those changes. As an addendum to the draft HRA, this report should be read and interpreted alongside that document.
- 1.3 The public consultation on Draft Plan Strategy took place in October-December 2018 and as a result of that exercise the Council wishes to make certain changes to the LDP. All the changes proposed can be found in the 'Schedule of Proposed Changes' Report. The changes include some minor and some focussed changes as defined in DPPN 10 Submitting Development Plan Documents for Independent Examination. However, the majority of the changes do not fall within either of those categories but are changes which are considered to represent logical and rational amendments to a policy or policy clarification in response to representations received during the consultation period.
- 1.4 All Proposed Changes require consideration by the Habitats Regulations Assessment (HRA) in order to check if they alter the 'likely significant effects' predicted in the published HRA Report or may lead to any adverse effects on site integrity.
- 1.5 This Addendum includes the following:
 - Screening of the Proposed Changes;
 - A record of those recommendations of the HRA which have been implemented through the Proposed Changes.
 - Conclusions on whether the Proposed Changes represent a likely significant effect for any site selection features and whether further assessment is required.
- 1.6 The HRA will be added to and finalised following public consultation and independent examination of the draft Plan Strategy, then published alongside the adopted Plan Strategy.

2. Statutory Requirements

- 2.1 Regulation 43 of the Conservation (Natural Habitats, etc.) Regulations (Northern Ireland) 1995 (as amended), requires an appropriate assessment to be undertaken of plans and projects which are likely to have a significant effect on an International site in Northern Ireland, either alone or in combination with other plans or projects. This is known as Habitats Regulations Assessment (HRA) and provides for assessment of the implications of a land use plan for International sites in view of their conservation objectives. It is accepted practice to also carry out HRA for International sites in adjoining jurisdictions where there is potential for a transboundary effect.
- 2.2 Given that the nature of the draft Plan Strategy has potential to have a significant effect on some International sites, a draft HRA was undertaken in our role as a competent authority to ensure the legal requirements of the Habitats Regulations are fully met. It therefore follows that any Proposed Changes to the draft Plan Strategy must also be assessed under the Habitats Regulations.

3. Findings of the main HRA

- 3.1 The main HRA of the published Draft Plan Strategy identified a potential for likely significant effects in respect of:
 - Habitat Loss: Direct habitat loss in an International site or loss of supporting habitat such as salmon spawning areas.
 - Direct Disturbance: This includes noise, vibration or light disturbance during construction or operation, or the presence of people on land developed for recreational use.
 - Indirect Disturbance: Disturbance beyond development sites arising from increased levels of recreation including watersports.
 - Introduced Species: The introduction of invasive species, non-native, competitive or predatory species.
 - Aerial Emissions: Aerial emissions primarily arise from industry and transport but domestic fuel and agricultural intensification are also sources.
 - Water Pollution: Deterioration of or failure to improve water quality due to direct runoff of pollutants, including fuel, chemicals and sediments, from development during construction or operation or indirect pollution due to inadequacy of wastewater treatment infrastructure.
 - Hydrological Change: Alteration of the hydrology of sensitive habitats and species by either increasing or decreasing runoff or water percolation into aquifers.
- 3.2 The HRA made some recommendations to enhance the protection for International sites under the LDP, and further reduce the risks of adverse effects on site integrity. These recommendations are set out in chapter 7 Outcomes and Recommendations of the HRA report. Given that all individual

projects will be subject to HRA, these recommendations are not essential to ensuring that the Plan Strategy is compliant with the Habitats Regulations. They would, however, enhance the protection for International sites under the LDP and further reduce the risks of adverse effects on site integrity, including from cumulative effects. A few of these recommendations have already been incorporated in the draft Plan Strategy, whilst others have been incorporated in the Proposed Changes. Some are to be implemented at later stages.

4. Approach to screening of Proposed Changes identified as relevant to the HRA

- 4.1 During the Draft Plan Strategy consultation exercise held between 26 October and 21 December 2018, a total of 322 individual Representations raising 659 issues, were made in relation to the Draft Plan Strategy and associated assessments. Of the 322 representations received, 6 raised 26 issues related specifically to the content of the HRA Report with a further 76 (duplicate copies of the same representation) seeking clarification on a copy of the HRA and Terms of Reference. A copy of all representations received and the Council's response to them are dealt with in the LDP Draft Plan Strategy Consultation Report.
- 4.2 As a result of analysis and consideration of the representations received, the Council has recommended a number of Proposed Changes to the published Draft Plan Strategy. A list of these can be found in the Schedule of Proposed Changes.
- 4.3 The Proposed Changes to the draft Plan Strategy are extensive but the majority of the changes are irrelevant to the HRA work which has already been completed. Some for example relate to introductory text, administrative text or to appendices that do not have any relationship to international sites. A number of the changes have affected the wording of policies and corresponding policy clarification paragraphs whilst others relate only to updates/changes to clarification paragraphs. The majority of these are not considered to have any effect on International sites. They are however recorded in Table 1 to provide a record that they have been considered. The minor editing changes are all corrections or minor amendments in the interests of consistency and are not considered further in this addendum. Those policies for which no changes are proposed have not been reviewed at this time.
- 4.4 Table 1 refers to the change or changes that apply to Draft Policies or other parts of the draft Plan Strategy. The details of those Proposed Changes are found in the 'Schedule of Proposed Changes' Report. The HRA screening category is presented in Table 1 followed by the justification for that category. In screening the Proposed Changes the categories identified in Section 4 of the draft HRA have been applied. These are copied below for ease of reference and explanations can be found in the draft HRA.
 - 1. General Policy Statements

- 2. Plans or projects referred to but not proposed
- 3. No likely significant effect
- 4. Proposals too general to assess
- 5. Potential minor effects
- 6. Potential significant effects

Where a Proposed Change addresses a recommendation from the draft Plan Strategy the recommendation is indicated in brackets.

5. Overall Conclusion

- 5.1 This addendum highlights the effects that the Proposed Changes to the LDP Draft Plan Strategy have had in regard to the Draft HRA of the Draft Plan Strategy. The Council has identified a schedule of changes. Those changes were assessed. Some of the changes implement recommendations 1, 3, 4 and 10 of the draft HRA. All the recommendations will be reviewed when finalizing the HRA to ensure that those that require implementation in the Plan Strategy have been addressed.
- 5.2 The relevant policies have been subject to screening under the Habitats Regulations and all but IB06, MIN01 and FLD05 have been screened out of further assessment according to the categories referred to above. For those policies screened out of further assessment they have been assigned to a screening category which allows them to be screened out as unlikely to have a significant effects either alone or in-combination. As such, no further assessment 'in combination' is required and there is no requirement to progress to an appropriate assessment for those policies.

However Draft Policy MIN01: Minerals Development introduces text relating to designated sites which could be a perceived policy conflict, although it is made clear elsewhere in the draft Plan Strategy that no policy should be read in isolation and all relevant policies will apply. Therefore, in finalising the HRA, the changes will be considered further through appropriate assessment and mitigation implemented if necessary.

- 5.3 In reviewing those policies subject to Proposed Changes it was considered that the changes to Draft Policy IB06: Agricultural and Forestry Development might be construed to be mitigation as they address an impact known to significantly affect international sites. Therefore, in finalising the HRA, the changes will be considered further through appropriate assessment to fully test the mitigation.
- 5.4 On review of Draft Policy FLD05: Artificial Modifications of Watercourses it is considered that there is a risk of likely significant effects in the event that culverting, albeit limited to 10m, obstructs the passage of salmon. This will be considered further in finalising the HRA and mitigation implemented if necessary.

5.5 IB06, MIN01 and FLD05 will be subject to further assessment to include consideration of the need for and effectiveness of mitigation. The HRA will be added to and finalised following public consultation and independent examination of the draft Plan Strategy, then published alongside the adopted Plan Strategy.
