**LOCAL DEVELOPMENT PLAN 2030: DRAFT PLAN STRATEGY – STATUTORY CONSULTATION**

I refer to your e-mail of 25 October regarding the above plan.

The Department of Education has several new build, School Enhancement and Fresh Start projects in the Fermanagh & Omagh District Council area.

In 2012 the following new build project was announced to advance in planning:-

Enniskillen Model Primary School – 14 class base Primary School and 2 speech and language provision classrooms.

In 2013 the following new build projects were announced to advance in planning:-

Devenish college/Lisnaskea College – 850 controlled post primary school;

Enniskillen Royal Grammar School – an amalgamation of Portora Royal and Enniskillen Collegiate – 900 pupil voluntary grammar school;

Gaelscoil na gCrann – 7 class base Irish Medium primary school and single nursery unit.

In 2013 two schools were approved under the first call of the School Enhancement Programme:-

St Michael's Grammar School – pavilion and 3G pitch on school's playing fields;

Erne Integrated College – new sports hall, learning support, sixth form and refurbishment.

In 2016 the following project was announced to advance in planning under the Fresh Start Initiative:-

Enniskillen Integrated Primary School – 7 classbase extension.

In 2018 the following project was announced to advance in planning under the second call of the School Enhancement Programme:-

St Kevin's College – a 2 storey extension with associated link to the existing school building.
