If we don't, these events will happen more often.




The strategy contains the things we will do between now and 2030.

#### **Theme 1 - Sustainable Communities**



Sustainable communities are places where people want to live now and in the future.

#### What will we do to make communities more sustainable?

The intended results for the Sustainable Communities theme are:



Homes and Communities are energy efficient



Sustainable communities reduce carbon emission.



Reducing **carbon emissions** means reducing the burning of fuels such as coal and oil.



Burning these types of fuels puts carbon dioxide into the air.



Reduce the amount of waste going to landfill.



Support and encourage other travel options including walking and cycling.



Supporting local communities to get funding



Promote sustainable tourism.



Encourage people to buy local produce.

#### Theme 2 - Sustainable Council

Promoting sustainable travel for employees like cycling and car sharing.

Train our staff on sustainable development.



Look for further funding opportunities.



Minimising the impact from any future developments.



Increasing the amount of recycling.



Reducing the amount of waste going to landfill.



Improving air quality.
